____ TRAVEL DOCUMENTATION Passengers are responsible to obtain the correct travel documentation (passport, visa, identification) for the destination(s) to be visited. Passports are required to be valid for at least 6 months beyond the travel dates.

____ TRAVEL INSURANCE Passengers have the option to purchase travel insurance. If purchased, coverage begins only after payment of the insurance premium and that the pre-existing condition waiver applies only when payment of the insurance premium is added to each reservation within 14 days of passenger reservation.
