Summit Hill Farms Adventures Event Policies

- Reservations must be made 2 weeks prior to the event date. Short notice events will be handled on a case by case basis.
- Deposit of 50% of event total is due at time of booking. Final balance is due day of event upon arrival. Set up will not begin until final/full payment is received. This time will cut into your event time. By cash, electronic payment, or check. Returned check fee of \$50.00. There is a transaction fee for all electronic payments.
- Due to the nature of our 'out of office' service we need you to take into account that there are acts of God that are beyond any normal person's control such as but not limited to, inclement weather such as rain, snow, sleet, hail, lightning, thunder, earthquakes, heavy winds, etc. It is the duty of the event host to notify us of any inclement weather at the events location within 4 hours of the scheduled event. The event can be rescheduled on another day. However, if the host fails to notify us of inclement weather and we make an attempt to arrive at the event location deposits will become non-refundable due to the fact we spent irreplaceable time prepping, loading and transporting animals and equipment.
- Due to unpredictable traffic conditions and inclement weather that can vary depending on our distance from the event, please be advised that the scheduled start time of your party is subject to a 30-minute leeway. Although we make every attempt to arrive early and be prepared.
- Reserved parking is mandatory for our vehicles and trailer. We need a safe and adequate location to unload and load our animals and equipment. Our rig is approximately 40 feet long and the area needs to be easily accessible. If a spot is not reserved it can and will cut into our set up time. We have to have ample amount of space for pulling and backing the truck and trailer into the designated area. We reserve the right to leave without a refund, if the area is not easily accessible or we determine there is no way to accommodate your area.
- Please be sure to provide a safe and debris free area for our farm animals. This area needs to be a minimum of 30 feet by 30 feet. If your area is not big enough, please reach out in advance to us, so we can make proper accommodations. The area needs to be free of landscaping as the animals will consume and destroy all forms of landscaping and we are not responsible for damage, we also need to keep poisonous plants away from the farm animals so by keeping all landscaping out of reach we are ensuring our animals' well-being. Keep in mind if the area is grassy, damage may occur and we are not liable for those damages. We prefer a grassy, shaded area for the animals to enjoy the event as well. We will do our best to clean up the area, however, there will be remnants remaining. No chemical spraying on property within 15 days of the event. If an animal becomes ill due to said chemical spray, you will be liable for all vet bills and expenses occurred for the ill animal.
- We reserve the right to include or exclude animals for any reason we deem necessary as we are solely responsible for our animals and we need to consider their health and well-being.
- We will provide feed for your guests to feed the animals for small events. For larger events, we sell the feed to participants. Our animals are only allowed to eat a certain amount of feed, so this helps to ensure the well-being of the animals. We will cut off feed once the intake limit is reached for the animals.

Please take note of the following rules that the event host and its attendees must follow:

- ALL minors and incapacitated individuals must be supervised at all times. We will not be responsible for injuries or accidents incurred.
- Our farm animals are living and breathing creatures, not machines. They are to be treated with respect by the event host and all of the host's attendees. No running, chasing, hitting, screaming at, yelling at, throwing at, picking up or exhibiting any threatening behavior towards the animals.
- No climbing or sitting on our pens or fencing is allowed. Damages to our equipment by host or host's attendees will be the sole responsibility of the event host.
- All outside food and drinks must be kept far from the animal zone for the safety of the animals. There will be designated food that is appropriate for feeding said animals.
- No dogs are allowed anywhere near the animals. This is for the safety of our animals, ponies and participants. Dogs are unpredictable around livestock and can cause fear induced behavior that can become extremely dangerous to our animals well being as well as create a very unsafe environment for the participants of the party. If you know there are dogs at the designated location of the event, all efforts must be made to secure the said dog(s) out of sight in an adequate location.
- Shoes in general are required around the animal zone.
- No smoking is allowed anywhere near our farm animals or handlers.
- Only handlers are allowed to handle the ponies or animals at any time.
- Hand sanitizer will be provided, please instruct participants to use it often. If you are able, a wash station, would be greatly appreciated!
- Event Host must fill out and sign a waiver and release of liability and accepts the sole responsibility of all actions by participates and guests during the event.

If at any time the party becomes unsafe or dangerous we reserve the right to leave without a refund.

This is a binding contract and by signing below you are agreeing to all of our policies and agreeing to abide by all of our rules. The event host is held responsible for his/her own behavior and its event attendee's behavior and ability to follow our rules.
