More about Northwest Specialty Hospital

Acute rehabilitation offers a continuum of care designed to rebuild a patient's strength, endurance and achieve recovery following a debilitating injury, illness, or medical condition. The department will provide specialized programs for patients suffering from stroke, brain injury, major trauma, medical deconditioning and other disabling conditions, neurological conditions, Parkinson's disease, spinal cord injury and amputation. The department will include a full-scale therapy gym, transitional care apartment, which will allow patients to prepare for day-to-day functions prior to discharge, access to a multispecialty team, and programs for family members to engage in the patient's care.

Adult Behavioral Health is designed to provide a secure, comfortable space for patients requiring inpatient care for mental health disorders such as anxiety and agitation, bipolar disorder, major depression, psychosis, schizophrenia, substance use disorder and suicidal ideation. The department is led by a physician medical director and a multispecialty care team including physicians, hospitalists, APRN's, nurses, CNA's and licensed social workers. In addition, the department will have a dedicated wing for adults ages 55 and older who are being treated for dementia, Alzheimer's, and related memory-associated conditions.

Breast Cancer Screenings



Breast cancer is a significant health concern for women, being the second most common cancer and the second leading cause of cancer-related deaths among women in the United States. Regular screenings play a crucial role in early detection and treatment. According to the American Cancer Society, about 1 in 8 women (roughly 13%) will develop invasive breast cancer in

their lifetime. In 2023 alone, almost 300,000 new cases of invasive breast cancer were diagnosed in U.S. women, along with about 56,000 new cases of non-invasive breast cancer.

To promote early detection, the Centers for Medicare and Medicaid (CMS) has established guidelines requiring healthcare providers to

ensure their patients receive timely mammograms. Meeting this requirement is essential not only for patient care but also for maintaining compliance with quality programs.

Starting this year, Silver State ACO will be required to report this measure to CMS on behalf of their participating practices via a Medicare Clinical Quality Measure (CQM), ensuring accountability and improved outcomes. Medicare CQMs are electronic-based measures that are populated and extracted directly from your Electronic Health Record (EHR) system via a QRDA Category 1 file.

The Medicare (CQM) for **Breast Cancer Screening** applies to women between the ages of 40 and 74. It requires patients in this age group to have had a mammogram within the current measurement period (2025) or the 15 months prior. Each EHR system has its own method of documenting this measure. Compliance can be achieved through integration with an imaging center or by entering the information into a *designated field*. We strongly recommend that practices reach out to their EHR company liaison to fully understand the necessary workflows.

How to Meet the Requirement

- Find Out Who Needs a Mammogram: Use your electronic health records (EHR) system to generate a list of female patients who have not had a mammogram in the last two years.
- Educate and Encourage: Some patients may avoid screenings due to fear or do not realize how important they are. Take the time to explain the benefits of early detection and address any concerns they may have.
- Set Up Reminder Systems: Send automated phone, text, portal, or email reminders to notify patients when they are due for a mammogram. During office visits, staff should also remind patients about the screening.
- Keep Track of Screenings: Make sure all completed mammograms are documented in the patient's record and follow up with patients who are overdue.

Following Medicare's **Breast Cancer Screening** guidelines is not just about meeting a requirement - it's about making sure patients get the care they need. The National Cancer Institute study shows regular mammograms reduce breast cancer deaths by 40%. Encouraging

SECURITY REMINDERS

As the weather warms and we dust off our outdoor furniture, clean our closets and break out the spring and summer wardrobes and toys, it's a great time to do the same in our practices. It's time to review, refresh and renew security protocols and directives.



Here are some suggestions:

- CMS does not allow medical practices to employ anyone who is listed as "excluded" on the OIG's list. That includes those who may not have appeared on the list when you first employed them. Keeping in mind that some employees have part time jobs elsewhere, and that there may be a lag to OIG's adding names to the list, new employees may have slipped "through the cracks." Now is a good time to check the list for the names of all your employees. Here's the link: https://exclusions.oig.hhs.gov.
- Review all systems and staff access. Have all the employees who
 left this year had their login access deactivated to all systems? Best
 practice is to keep a log for each system. When employees are
 hired or leave, each log should be updated. Now is a great time to
 do an overall review.
- Have security updates been uploaded for each system? When did you last discuss protocols with your IT provider?
- Create a calendar of educational forums or events. Education, education, education. Important things bear repeating.
