In June, the virtue of **FAIRNESS** calls us, as a Catholic community, to treat others with mercy, to be open-minded and to act justly. In light of the COVID-19 pandemic, we have a moral obligation to contribute to the common good. Cardinal Collins offered us a special message of Igniting Hope which is rooted in Catholic Education Week "...that's really what Catholic education is all about; it lifts us beyond ourselves and sends us out to serve our neighbour and, in doing that, to serve our Lord God." As is my practice, I would like to provide you with some updates on issues, events and activities affecting the DPCDSB and our Mississauga wards 9 and 10 school communities.

School Closure

Education Minister, Stephen Lecce has announced that all publicly funded schools in Ontario will remain closed for the remainder of the 2019-2020 school year. This decision is based on the expertise of the Chief Medical Officer of Health, the COVID-19 Command Table and medical professionals at the Hospital for Sick Children. The provincial government has referenced that it will communicate the plan for the safe reopening of schools. Parents can anticipate an update prior to the end of June. Retrieving Student Belongings

DPCDSB has communicated the needs of parents/guardians and families to the Ministry of Education, in regards to obtaining students' belongings from their school. The Ministry is supportive of working with school boards and our local public health units and is currently developing a provincial template protocol to allow controlled re-entry for staff, parents and students to retrieve their personal items. We anticipate that schools will be able to schedule access by mid to late June, depending on the size of the school.

Report Cards

Student report cards will be distributed electronically prior to end of the current school year. Hard copies of transcripts, diplomas and awards will be available to students when the graduation ceremonies can be scheduled. The Ministry of Education has assured school boards that all students who were on track to graduate from secondary school will be able to graduate.

Synchronous Learning

We recognize the dedication of our DPCDSB Catholic parents/guardians, students, educators and staff in supporting Catholic education. The collaborative work of everyone has helped to ensure the delivery of Continuity of Catholic Learning for our students and children. We know that learning is enriched by interaction in meaningful ways. The Ministry of Education and the DPCDSB is supportive of synchronous delivery for teacher-led learning and providing support for educators and families. On May 19, a guide for parents/guardians was released to the system which outlined DPCDSB's expectations for safe and secure distance learning. Our approach to Synchronous Learning provides a reciprocal framework where students have direct interaction with their educators to receive instruction and assessment/evaluation in an authentic and timely manner. Teachers may use multiple formats and flexibility of instruction as related to set times and scheduling to address the needs of their students. All educators have been encouraged to use DPCDSB-approved platforms to ensure that synchronous learning is occurring during this Continuity of Catholic Learning. In addition, the DPCDSB has also recently purchased licenses to the secure *Zoom videoconferencing* platform. A follow-up online community survey for DPCDSB parents/guardians is available on www.dpcdsb.org and is open until June 3, 2020. This will be important in guiding our decision making.

Wellbeing

“When the well-being of children and students is supported...we are meeting the conditions needed to help them learn, grow, and develop a positive sense of self.” (Ontario’s Well-Being Strategy for Education).

Supporting well-being and mental health is so integral to the work we do. It is also articulated clearly and explicitly within the core principles in the Board of Trustees’ *Multi-Year Strategic Plan (2019-2023)*. DPCDSB continues to meet regularly with our partners to ensure we are aligned with the provincial direction, and aware of the supports available to our students and the changes in service delivery models, given the pandemic. Broader Public Sector Redeployment

With the most recent emergency order by the province, the voluntary redeployment of support staff, such as custodians and maintenance workers can assist in the critical staffing shortages in long term care homes, hospitals and other healthcare settings. This opportunity is available to education employees who are not currently working during the school closure period. We have been assured that only those individuals who are not directly supporting students will be approved by the board. The agreement between boards, unions, workers and the ministry will end when the emergency orders are removed. This initiative is not intended to disrupt the operations of school boards.

Summer Learning

The Ministry intends to support the usual range of summer programming as well as additional programming. Funding will be supported through the Provincial Priority Funding grants. More information to follow.

Secondary Summer School Registration

Online registration is open for secondary students. Due to COVID-19, whether classes will be offered in person, online or a combination of both has not yet been confirmed yet. The decision will be made later in June. It is suggested that students register as soon as possible. [For more information](#) | [To register](#).

PRO-Grant Funding

Due to the significant decrease in Parent Reaching Out (PRO) Grant funding by the Ministry of Education, schools did not receive any PRO-Grant funds. Central Committee for Catholic School Councils (CCCSC) members decided to use all PRO-Grant funds to support a variety of system-wide parent engagement opportunities. Unfortunately, three parent engagement events were cancelled in the spring, as a result of pandemic related school closures. We have not received any updates from the Ministry regarding unspent PRO-Grant funds for the 2019-2020 school year.

Childcare

School boards have been directed to refrain from charging childcare rent. In addition, the Ministry has mandated that childcare fees will not be charged to parents to hold their spots during the school closure period.

Grants for Student Needs (GSN)

The budget submission deadline for school boards will be extended given the delay in releasing the Ministry's release of the GSN.

OSSLT 2021

Students graduating in January 2021, who have not completed the literacy requirement, will have the option of adjudication or a literacy course. DPCDSB is working with the Ministry of Education to determine how to best address the double cohort. Parents/guardians and students will be informed when more information is available.

Construction Update

The province has recently revised the list of essential construction projects, including the renewal of new school and childcare projects. In February 2020, the Ministry of Education provided DPCDSB with an Approval to Proceed (ATP) in two of our DPCDSB elementary schools in Mississauga north, to tender the construction of a new childcare centre: St. Albert of Jerusalem CES and an expansion of the existing St. Edith Stein CES child care centre. While DPCDSB staff were hoping to move ahead at that time with the construction of these projects, the COVID-19 pandemic forced the board to pause all major school construction activities. The Government of Ontario has recently permitted school construction projects to resume. As such, efforts are underway by staff to ensure that the necessary permits are received from the City of Mississauga and that the tender documents can be prepared for these two childcare centre projects.

DPCDSB is staging the construction activity at these two schools in a sequential manner with the St. Albert of Jerusalem childcare centre project taking place first, followed by the St. Edith Stein childcare centre expansion. This will allow children at the St. Edith Stein childcare centre to be accommodated at St. Albert of Jerusalem on a temporary basis while the construction work takes place at St. Edith Stein. Exact timelines for this work are still to be confirmed. However, it is currently estimated that the St. Albert of Jerusalem project will commence in August 2020. The St. Edith Stein work will be scheduled to commence sometime after January 2021. However, as a result of current requirements due to COVID-19, once construction begins, workers will be subject to physical distancing and other health and safety guidelines. This may extend the construction timelines beyond those noted above.

Parent Engagement Evening

We extend our appreciation to Dr. Pepler for providing our parent communities with an online presentation on cyberbullying. DPCDSB and the Board of Trustees have engaged the expertise of Dr. Pepler to inform our work on bullying prevention policies, procedures and practices. Dr. Pepler is a professor of psychology at York University and an expert on bullying. The Fair Chance Learning (FCL)

An organization affiliated with Microsoft Canada, is forming an *Education Onward Tech Committee* to develop some key learnings from the overall remote learning plans that are in play in Ontario. They have reached out to four directors of education from across the province, including DPCDSB. We are so pleased to have DPCDSB represented on this committee.

13th Annual Volunteer of the Year Award

Volunteers play an important role in our schools, helping to build vibrant, caring, inclusive and faith-filled communities. The Central Committee for Catholic School Councils (CCCSC) acknowledges these dedicated individuals who make a significant contribution to supporting Catholic education. The award process is also a means to thank our volunteers for their continuous years of commitment and dedication.
