1. Voluntary Release, Acknowledgement and Acceptance of Risk by Participants:

- a. In order to participate in the activities at Crooked River Campground I and my spouse/significant other agree to hold harmless the Campground and any officials, property owners, employees, other campers, advertisers and promoters.
- b. I and my spouse/significant other waive any right to make claims or lawsuits against them. I acknowledge that the activities in which I and my spouse/significant other and or my child is about to participate in are not essential services provided by Crooked River Campground.
- c. I and my spouse/significant other understands and acknowledge that there are certain risks involved with the activities in which I and my spouse/significant other or my child are about to voluntarily participate.
- d. I and my spouse/significant other understands that these risks known or unknown, anticipated or unanticipated may also result in injury, death, illness, disease or damage to myself, my child, others or property.
- e. I and my spouse/significant other voluntarily agree and promise to accept and assume all responsibilities, and injuries, death, illness, disease or damage to myself, my child, other persons, or property that arise from our participation in these activities.
- f. Mine, my spouse/significant other or my child's participation in these activities is voluntary and no one is forcing us to participate in spite of the risks.
- g. I and my spouse/significant other understands the effect of the waiver and acceptance of risk on our legal rights.
- h. My signature indicated that I and my spouse/significant other has read the above rules and this entire document, understand it completely, acknowledge that it cannot be modified or changed in any way by oral representations, and agree to be bound by its terms. This agreement shall be binding on behalf of my heirs, my assigns, my personal representative, my stand or myself.
- i. Children under 18 years of age signature of parent or guardian is required below to accept all liabilities.

2. WISCONSIN LAW Definition:

Wisconsin Statutes 895.525 (3) & (4) States: A participant in a recreational activity accepts the risks inherent in the recreational activity of which the ordinary prudent person is or should be aware.

- a. A participant in recreational activity is responsible to do all of the following:
 - i. Act within the limits of his or her ability.
 - ii. Heed all warnings regarding participation in the recreational activity.
 - iii. Maintain control of his or her person and the equipment devices or animals the person is using while participating in the recreational activity.
 - iv. Refrain from acting in any manner that may cause or contribute to injury to himself or herself or to other persons while participating in the recreational activity
- b. A violation of this law constitutes negligence. Wisconsin State Statutes 895.525 (3) & (4).
