SEASONAL PET POLICY

You have indicated you have pets that will be camping with you at Crooked River Campground _ here is our policy and the consequence if not following the rules of this policy could give campground cause to require the pet to be removed from the property.

Pet Rules/Regulations in random order:

1. Pets not allowed in your camping unit or in the campground are all farm and all exotic animals.
2. Any pets other than farm or exotic are allowed and are limited to no more than two pets per campsite unless approved by management.
3. For business insurance purposes the dog species that the campground cannot allow in our campground are: **PIT BULL, ROTWEILER and DOBERMAN**. The only exception allowed is individuals that permanently reside on the campground property within the two permanent homes.
4. Daily guests are not allowed to bring their pets to the campground.
5. Prior to their stay overnight guests must sign acknowledgment of the campground pet policy form.
6. Pets **MUST** be on a secure leash at all times when outside of your camping unit and never left unattended.
7. Pets are to be kept inside your camping unit or a secure external kennel when you are not present.
8. Pets are to be kept quiet at all times and excessive barking is not acceptable.
9. Pet waste anywhere in the campground is to be picked up and properly disposed of.
10. With your pets be mindful of your campsite neighbors and all site boundaries.
11. Pets are not allowed in the store, pavilion or shower house.
12. Pets are not allowed at the pond, beach or sand areas.
13. A leash is not required if you install a management approved invisible fence on your campsite perimeter.
14. All pets must have **current rabies tag on their collar** whenever on campground property.
15. No animals may be boarded at any time.
16. Children under the age of 14 should not walk their pets or visit the dog park without adult supervision. This rule is to protect both our campers and their pets from any altercation that could occur or the possibility of injury.
17. Copy of your pet's current vaccination records including but not limited to rabies **MUST** be on file with the campground. It is your responsibility to provide updated copies to the office each season.
18. **Should your dog bite any other animal or human at the campground you MUST immediately contact campground management. Once proper paperwork by authorities has been completed and the animal has been released the Camper is to remove their pet from the campground without question. It will be at the discretion of the campground if/when they may return.**
