Member Rules

Members must be a registered business with a current ABN.

Members must operate on the Southern Moreton Bay Islands.

Attendance at members meetings will require sign-in and provision of business and attendee details.

The failure to adhere to the Member rules and Code of Conduct can result in the termination of membership.



Code of Conduct

Abide by the requirements of the Constitution, including actively participating in meetings.

Understand, support and promote the Vision, Purpose and Values of the SMBI Chamber of Commerce. This includes:

- supporting the promotion and enhancement of business growth within the Southern Moreton Bay Islands
- co-operating with and respecting fellow members and volunteers
- respecting the reputation, profile and status of the SMBI Chamber of Commerce, and representing this accordingly
- respecting the roles of the SMBI Chamber of Commerce committees

Observe the highest standards of ethics in business operations and conduct business activities in a reputable manner to reflect honourably upon the business community and fellow members. This includes:

- refraining from publicly disparaging the business practices of fellow members
- refraining from condoning or engaging in misrepresentation or unethical practices
- refraining from seeking unfair advantage over fellow members
- making true representation in all business advertising
- conforming to all relevant laws established by Local, State and Federal governments
