## WHAT DOES TORCH MORTGAGE, LLC DO WITH YOUR PERSONAL INFORMATION?

How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Torch Mortgage, LLC chooses to share; and whether you can limit this sharing.
