- _____ • **Private Room Rental Fee:** \$100; **Upper Patio Rental Fee:** \$50. Rental includes one (1) hour before and after the event for set up and tear down. The Rental Fee(s) plus a completed Reservation Agreement is required to reserve the Private Room or Upper Patio. **Rental Fee(s) must be paid in cash;** credit cards and gift certificates will not be accepted. A company check for payment must be approved by management.
- _____ • **Cancellation:** The Rental Fee(s) is non-refundable unless a fourteen (14) day notice of cancellation is received.
- _____ • **Catering:** Chances Bar & Video Gaming's catering menu is prepared by Rosati's and Eggspress Cafe. **Final count and food selection due ten days before event.** Cost of any deletions/changes after final count and food selection are the responsibility of reserving party. A \$100 Non-Preferred Food Vendor Fee must be paid in cash when reserving the Private Room if reserving party is bringing in food from another vendor.
- _____ • **Beverages:** No outside beverages allowed. All beverages, alcoholic and non-alcoholic, must be purchased and served through Chances Bar & Video Gaming. Only persons 21 years of age and older, with proper identification, will be served alcoholic beverages. Chances Bar reserves the right to refuse service of alcohol at its discretion.
- _____ • Beverage pricing is determined as the *current price of goods on the day of the event* unless otherwise stated in Special Requests/Agreements. Beverage levels are available and must be arranged with the coordinator/bar manager at least *seven days prior to event*.
- _____ • Special requests for beverages not on Chances Bar menu are welcome. Every effort will be made to accommodate requests. In the event that a request cannot be fulfilled, Chances Bar & Video Gaming will notify the contact at least five days prior to the event date.
- _____ • One bartender will be provided for the Private Room Event. Additionally, parties of more than 35 guests will be provided a server.
- _____ • Private Room seats up to 44 persons; four persons per 30x30" table. Furniture may be arranged to allow for larger standing room party requests.
- _____ • **Final Payment:** Bar and food service will be presented as one check unless cash bar service is requested. **18% gratuity will be added to all checks whether one or individual.** Gift certificates will not be accepted as payment during Private Events.
