ORDINANCE NO. 2-2026

AN ORDINANCE OF THE TOWNSHIP OF SALEM, WESTMORELAND COUNTY, PENNSYLVANIA, AMENDING THE TOWNSHIP'S RESTRICTED ROADWAYS ORDINANCE NO. 1-2024 EXHIBIT A BY ADDING ADDITIONAL ROADWAYS TO THE WEIGHT RESTRICTED HIGHWAY, ROADWAY OR BRIDGE LIST.

WHEREAS, the Pennsylvania Vehicle Code at 75 Pa. C.S.A. 4902 permits certain weight restrictions to be placed on vehicles traveling on Township highways, roadways, streets and bridges; and

WHEREAS, pursuant to provisions of Section 4902 of the Vehicle Code Act of June 17, 1976, P.L. 162, as amended, 75 Pa. C.S. 4902, the Salem Township Board of Supervisors enacted a Restricted Roadways Ordinance (Ordinance No. 01-2024 enacted September 18, 2024); and

WHEREAS, under the authority of such Ordinance and various amendments thereto, the Township has posted gross weight restrictions and reduced speed limits on all or portions of various Township highways, roadways, streets or bridges; and

WHEREAS, the Township of Salem, following the receipt of engineering studies, has determined that weight restrictions are appropriate on various additional highways, roadways, streets and bridges; and,

WHEREAS, the Board of Supervisors of the Township of Salem desires to add additional public roads to the List of Weight Restricted Roads as identified on Exhibit A in Ordinance No. 01-2024; and

WHEREAS, the Board of Supervisors desire to impose weight restrictions on those additional roads and highways, or portions thereof as identified in the List of Weight Restricted Roads identified as Exhibit A in Ordinance No. 01-2024; and

WHEREAS, the Board of Supervisors desire to amend the terms of Ordinance No. 01-2024 to incorporate those additional roads and highways, or portions thereof.

NOW, WITH THE FOREGOING RECITALS BEING INCORPORATED HEREIN BY REFERENCE THERETO, BE IT ORDAINED AND ENACTED BY THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF SALEM, WESTMORELAND COUNTY,

PENNSYLVANIA, AND IT IS HEREBY ORDAINED AND ENACTED BY AUTHORITY OF THE SAME AS FOLLOWS:

1. Exhibit A of the Township of Salem Ordinance Number 01-2024 is hereby amended by adding the following Highway, Roadway, or Bridge as follows:

Highway, Roadway or Bridge	From/To	Max Gross Weight
Orr Road (T-623)	From SR 1055 to Quarry Drive	10 Tons
McQuaide Drive (T-801)	From SR 0819 to Township Line	10 Tons
Quarry Drive (T-950)	From SR 1055 to SR 22	10 Tons
Thorn Run Road (T-722)	From SR 66 to Story Road	10 Tons
Keith Lane (Formerly T-929 now T-733)	Davis Road to SR 1055	10 Tons
Old William Penn Highway (Formerly T-628 now T-723)	SR 1055 to SR 1063	10 Tons

2. Exhibit A of the Township of Salem Ordinance Number 01-2024 is hereby amended by amending the following Highway, Roadway, or Bridge as follows:

Highway, Roadway or Bridge	From/To	Max Gross Weight
Bowman Road (T-638)	From SR 0022 to <u>SR 0119</u>	10 Tons

3. Exhibit A of the Township of Salem Ordinance Number 01-2024 is hereby amended by removing the following Highway, Roadway, or Bridge as follows:

Cullex Road/Quality Row (T-639 & T-911)	From SR 0022 to T-638 - .22 miles	10 Tons
