Eric Hageder asked what the likely hood of receiving these grants. Kerry Jobe explained that we already applied for the Mack and Kennan Dr. waterline extension in 2024. Because the state has been shut down for so long, they didn't meet to award. We don't know if we are going to get those grants or not. It was anticipated that we would receive notice by the 18th of November. Usually, it is a little earlier in the fall. By voting to reapply and by reapplying, if we don't get any or we get one we can talk to our consultant to raise one of the grants up to try to fight for that one. We could get both the Kennan and Mack but there is no guarantee.

Eric Hageder asked if there is anything available through the Feds. Kerry Jobe said if you do federal, you usually need a federal consultant/lobbyist to push it through.

Kelly Otto noted a typo in the resolution title. The title will be modified in the resolution from Tucker Drive to Tucker Road
