

**A RESOLUTION OF THE TOWNSHIP OF SALEM, WESTMORELAND COUNTY, PENNSYLVANIA APPROVING MODIFICATIONS TO THE FEE SCHEDULE AND CHARGES ASSOCIATED WITH ON LOT SEWAGE DISPOSAL SYSTEMS**

**WHEREAS**, the Township of Salem, Westmoreland County, Pennsylvania, has various properties within its geo-political borders served by on lot sanitary sewage disposal systems; and,

**WHEREAS**, the Township of Salem also has areas within its geo-political boundaries subject to continuing development by utilizing on lot sewage systems to meet their sewage facilities needs; and,

**WHEREAS**, the Township of Salem is authorized to regulate sewage facilities within the Township and has appointed a sewage enforcement officer (SEO) to review, inspect, permit and oversee the construction, maintenance, repair and removal of on-lot sewage systems therein under the Pennsylvania Sewage Facilities Act; and,

**WHEREAS**, the Board of Supervisors established fees for the review, inspection, permitting and oversight of the construction, maintenance, repair and removal of on-lot sewage systems in the Township through Resolution No. 06-2012; and

**WHEREAS**, the current sewage enforcement officer has requested a modification of the existing fee schedule for those services related to the review, inspection, permitting and oversight of the construction, maintenance, repair and removal of on-lot sewage systems in the Township; and

**WHEREAS**, the Board of Supervisors of Salem Township desire to approve such modified fee schedule by the adoption of this Resolution.

**NOW, THEREFORE, WITH THE FOREGOING RECITALS BEING INCORPORATED HEREIN BY REFERENCE THERETO, THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF SALEM, WESTMORELAND COUNTY, PENNSYLVANIA, HEREBY RESOLVE AS FOLLOWS:**

1. That the 2025 On-Lot Sewage Fee Schedule, and those fees charged for the services set forth therein, submitted by the Township Sewage Enforcement Officer, a copy of which is attached hereto, made a part hereof and marked Exhibit "A", be and are hereby approved.

2. This Resolution shall repeal and replace Resolution No. 06-2023 and the fee schedule referenced therein.

**Sewage Enforcement**
