**1. ADMINISTRATION**

- 1A. Motion made by Ken Trumbetta and seconded by Kerry Jobe to approve the advertisement for bids for the 2024 Road Paving Project. Final material and installation specifications will be discussed and determined along with bid receipt and opening dates.

This meeting is taking place due to the withdrawn motion to approve the install bids at the June 19, 2024, supervisor meeting. It was withdrawn due to the specifications of materials being used. Historically we have never used 19MM as a wearing course.

Bob Zundel suggested not rebidding and bid next year.

Bob Zundel said the problem bidding this late in the year will be finding someone to mill the roads. Rosewood is the only road not being milled.

The motion was made to bid 9.5MM as the wearing course and 19MM binder. Historically, we have always used 9.5MM as the wearing course. It is cheaper bidding material separate from labor but there is a problem with one company not wanting to install another companies' material. If we are using 9.5MM, we will need more materials to compact, and you will need more than 3". The depth numbers will need to be calculated for each course. The bid will be for installation and material combined with Forbes Road being milled and Rosewood not being milled. It will be okay to receive a bid for Forbes Road and not Rosewood and visa versa. The exact tonnage will be determined by the Roadmasters and Engineer. Brandon Firestone from Liquid Fuels will need to be involved if we are bidding as a project and they will

wind up doing the advertising. Bid receipt and open dates will be determined once Brandon reviews the project.

Vote: Ken Trumbetta and Kerry Jobe voted for the motion. Bob Zundel voted no.  
 Motion passed by majority vote.
