# <u>Architectural Control Committee Updates</u>

Due to several incidents, we need to ensure that the deeds and restrictions are upheld by the HOA Board and all neighbors. Recently enforcement action and fines were leveled against a homeowner for



non-compliance with HOA deeds and restrictions. Attorney fees were incurred by the homeowners association. We know this is a sensitive issue but in order to be able to address the bigger issues it is imperative that the Board is in alignment with the deeds and restrictions as written. An Architectural Control Committee has been appointed as specified within the deeds and restrictions.

Home projects resulting in a new structure or the exterior addition to or change or alteration are to be approved by the homeowners association Architectural Control Committee. To make this process as easy as possible there is a new project submission form available on the website at <a href="https://egmhoa.com/project-approval">https://egmhoa.com/project-approval</a>. Examples of projects that would require approval: deck/patio renovations, tree removal, driveway resurfacing, roofs, play structures, fences, and more. Please feel free to inquire about any planned projects and the board would be happy to let you know if it necessitates Architectural Control Committee approval. The process can take up to 60 days, but usually the turnaround is much quicker (1-3 days). We also welcome any questions regarding this process as we understand it is a change for neighbors that have been in the community for a while. That being said, the Board is also in the beginning stages of reviewing/updating the deeds and restrictions to confirm they continue to be in accordance with Michigan/Plainfield Township ordinances and restrictions as well as the wishes of the neighborhood community. We will be soliciting feedback from neighbors during this process so stay tuned!

#### **Dues**

A big thank you to our homeowners who have paid their annual dues in a timely manner! We appreciate your contribution to our neighborhood. To those homeowners who have not yet paid, please remember dues for the 2022 year are \$108.90 payable via check sent to Evergreen Meadows Homeowners Association, PO Box 415, Rockford, MI 49341 or Venmo at @Evergreen-Meadows by an extended deadline of March 28th, 2022 without incurring late fees.

The HOA Board is working on several ideas to utilize the funds to improve our neighborhood community. We are planning to explore future projects for improving the pond and the shared property located adjacent to the pond. We will be posting updates on the neighborhood website as we investigate options.

#### Sidewalks

For the sake of neighbors that enjoy using the sidewalks throughout the neighborhood, please ensure that walkways are kept clear during all seasons, including not only ice/snow in the winter but also trimming trees and bushes clear of the sidewalks. Sidewalks are also to be maintained by homeowners for unlevel concrete and trip hazards. Please contact the Architectural Control Committee for further guidance if needed.

#### Dogs

At the recent homeowners association meeting there were several questions related to dogs. Pet noise disturbances are handled by the township. Please contact Susan Thompson 616-726-8896 with the location of the dog, how many dogs, and a specific complaint (continuous barking, early morning barking, etc.). Dogs running loose in the neighborhood off leash/unsecured would be reported to the Kent County Animal Control at 616-632-7300 at the time when the dog is running loose.





### **Parking**

Please keep in mind as we move into the spring/summer camping and boating season that Article V, regulation 6 of the deeds and restrictions notes trailers, boats, inoperable or unlicensed vehicles, motorcycles, snowmobiles, motor homes,

or similar items should not be parked, kept, or stored on any lot except within a completely enclosed building. No such items shall be kept or stored outdoors. The Board does allow for a maximum of 48 hours for a trailer, boat or similar item mentioned above to be parked on a lot.

The Board would also like to request homeowners to avoid street parking, whenever possible, and to please use garage space and driveways for parked vehicles when able. This makes it easier for others to maneuver throughout the neighborhood, especially in the early morning, evening, and at night. It also helps drivers to have clear street vision to avoid any accidents with pets or children.

#### **Fireworks**

Happy 4th of July! ...okay so we know it is a bit early...but we thought we would remind everyone of the Plainfield Township ordinances on fireworks.

A person may ignite, discharge, or use consumer fireworks only on the following days after 11:00 a.m.: The Saturday and Sunday immediately preceding Memorial Day until 11:45 p.m. on each of those days; June 29 to July 4 until 11:45 p.m. on each of those days; July 5, if that date is a Friday or Saturday, until 11:45 p.m.; the Saturday and Sunday immediately preceding Labor Day until 11:45 p.m. on each of those days. December 31 until 1 a.m. on January 1.



If there are dry conditions and the Department of Natural Resources Fire Division notes extreme fire possibility the Fire Department may impose and enforce a no burning restriction that includes but is not limited to a ban on the ignition, discharge, or use of fireworks. Please be courteous to the neighborhood and ensure that any firework debris are limited to your property and are properly cleaned up and disposed of in a timely manner to limit any damage done to neighboring properties.
