We appreciate the dedication of SVDFFA members who are working at these events, the exhibitors and professional handlers in attendance, additional members of the purebred dog community assisting SVDFFA and the willingness of our judges to officiate in today's Covid 19 environment. We THANK each one of you.

To be able to hold these events there are **SHOW GUIDELINES** that must be followed. SVDFFA has a duty and responsibility to assure to the best of our ability that everyone in attendance is complying with those guidelines. Clearly SVDFFA wants to present a safe environment where exhibitors can exhibit their dogs in accordance with AKC Rules & Regulations Applying to Dog Shows as well as state and local requirements

We are not police officers and that is not our mission, but cooperation is expected and needed for a successful weekend.

Show Guidelines:

- 1) Face Masks are always mandatory while in the buildings no face shields without a mask
- 2) Social Distancing is Required - 6 feet separation in all areas, INCLUDING grooming spaces
- 3) There will be a one-time check in for wrist band & waiver signature available at multiple locations
- 4) Signed waivers from EACH person entering the building are required. You will receive a wristband in exchange for your waiver.
- 5) You must wear the wristband to be in the building. Do not discard until you are completely done with your weekend activities—only one will be issued per person.
- 6) Committee Members will be walking throughout to make sure everyone is complying
- 7) No General Public will be allowed to be in attendance
- 8) NO dryers or fans
- 9) Masks & hand sanitizer will be readily available throughout the building
- 10) There is to be no standing around rings, and no chairs around ring

- 11) Armbands will be laid out by time slots, no ringside catalogs will be available. Know your number!
- 12) This event will be a Show and Go event. Exhibitors shall arrive right before showing and leave after showing
- 13) Arena seating area is marked off for 6' distancing. Do not adjust.
- 14) Separate ring entrances & exits, and you should maintain social distancing in the ring
- 15) Follow traffic patterns thru the tunnels
- 16) Rings 1 thru 4 will have limited temporary crating areas near the rings
