#### **Running Order:**

The running order will be posted at the score table and in the blind for each trial. All requests for running order changes must be approved by the Trial Secretary. Move Ups/downs/lateral will be allowed trial-to-trial. **Master Blind:** 

Blind description: size 10x15, 5 per blind, masters 4/blind, undercover in the pavilion

#### Awards:

Awards are handed out at the awards table.

#### All Classes:

Qualifying Score: Brown Flat Ribbon

#### Novice and Above:

Rosettes are offered for new titleholders.

High In Class Rosettes

Ribbons are offered for First through Fourth place in each height division.

#### Notice to Exhibitors:

- This event is open to all dogs 6 months of age and older.
- Please be familiar with Rules and Regulations at <a href="https://barnhunt.com/barnhuntrules.html">https://barnhunt.com/barnhuntrules.html</a>
- Withdrawal of entry before the closing date will receive a refund less a \$5 processing fee.
- Refunds will be mailed 7 days after the event.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee
- Exhibitors are responsible for complete accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when in the ring.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment. Checks must be made payable to GCPR. Entries where payment has not been received within 7 days of receipt of entry will be cancelled. Dogs may enter both Instinct and Novice in the same trial until the dog has earned the RATN title. A dog that has earned an RATN may no longer enter the Instinct Test. Exception: If the dog is already entered in Instinct at the trial and earns its Novice title, it may continue to compete in Instinct for that weekend only.

- Dogs must be eligible to run a class at the time of entry. Dogs who complete a title at a trial may
  move up, at the discretion of the handler, in the next trial. Please make move-up requests at the
  score table before the lunch break or before leaving the afternoon trial. Handlers are responsible for
  making the request in time for the move-up to be processed.
  Results
- Please check your results at the event. It is much easier to fix an incorrect score BEFORE the results are sent into Barn Hunt Association. It is
- the handlers responsibility to make sure all information and scores are correct. Bitches in season:
- are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial. Full refund for bitches in season less any PayPal or Credit Card fees processing fee, up to 48 hours before the event. After this time no refunds will be given. If bringing a bitch in season, please inform the Trial Secretary prior to the trial and inform all exhibitor's at the judge's briefing.

## Part 14: Regular Classes

#### SECTION 1. A and B Classes

Novice, Open, Senior, and Master are split into A and B divisions. All competitors enter each class level in the A division until they finish the title at that level. Once a competitor finishes a title from the A division, they are no longer eligible to compete at that level in an A class and must either move up, over (lateral move) or down. Extra scores earned in A do not carry over to B classes. Competitors are responsible for entering the correct class.

#### SECTION 2. What Class to Enter


When sending in an entry prior to the Event, the Class entered depends on titles previously earned. Competitors can enter their dog in any class that dog is eligible for, including B classes at a lower level (for example, a dog with a RATM can enter either Master B, Novice B, Open B, or Senior B.

- 1. Some Clubs may offer options to enter more than one class type per Event (e.g. Open B on Saturday and Senior A on Sunday). Class options will be listed in the Premium.
- 2. Dogs cannot be entered in a class they are not yet eligible to enter. Any dog entering a class they are not eligible to enter will have any and all qualifying scores removed for that class.

#### SECTION 3. Moving Up, Down, or Over During an Event

Competitors can move up, down or over (A to B at the same level) during any Event where those choices are offered. Dogs achieving RATM from Master A must move to Master B for RATCH and RATCHX and above.
