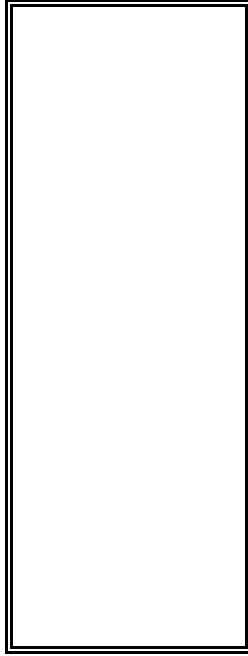

Notice To Exhibitors

1. Owners are responsible for errors on entry blanks and for entering the same dog twice. Entry fees will not be refunded in the event of errors or cancellation of entries received after published closing date, nor in the event that a dog is absent, disqualified, lame, excused by the Veterinarian or Judge, or barred from competition by the Show Committee.
2. **BITCHES IN SEASON** are not permitted to compete in Obedience or Rally Trial classes. If a female is withdrawn from competition for coming into season and the Event Secretary is notified no later than ½ hour prior to the start of the first class, then the club will refund the entry fee. **A processing fee of \$10.00 per entry will be retained.**
3. If, because of riots, civil disturbances or other acts beyond the control of the Management it is impossible to open or complete the show, no refund of entries will be made. Extreme weather conditions, such as, but not limited to hurricanes, lightning, extreme heat or earthquakes, must be considered for the health and safety of the dogs, exhibitors, and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fees will be made.
4. The American Kennel Club requires that each show-giving club collect the following fees on each entry and forward to AKC. The fees listed in the Entry Fees section already include these fees. Included are the following:
 - **Show & Obedience:** An AKC RECORDING FEE of \$.50 is required on each first entry of a dog, and an EVENT SERVICE FEE of \$3.00 for each entry in Licensed or Member club show, obedience trial, or tracking test in recordable, single-entry classes.
 - **Rally:** A RALLY RECORDING FEE OF \$3.50 shall be required for the first rally entry of each dog, and \$3.00 for each additional rally entry same dog. a recording fee of \$3.00 shall be required for each additional rally entry of the same dog.
 - **Beginner Puppy:** An AKC FEE OF \$2.00 is required on each entry in the 4-6 Month Beginner Puppy Competition.
5. Entries must be made on Official AKC Entry Forms, or photocopies with the agreement and rules on the reverse.
6. Dogs must be ready for judging. The Club and/or its Show Secretary will not be responsible for and are not obligated to provide any service for notifying exhibitors or their agents of class judging. Judges need not wait for dogs holding up class judging.
7. Dogs need to be at the show at scheduled time of judging and may leave immediately after being judged unless needed for further judging.
8. Dogs, which according to their owners' records have completed the requirements for a championship after the closing of entries for the show, but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed competition, provided this transfer is made at least one-half hour prior to the start of any regular conformation judging at the show.
9. No dogs will be allowed in the show area except those entered in the show. There are no provisions for unentered dogs.
10. **PLEASE NOTE THAT NO PUPPIES UNDER SIX MONTHS ARE PERMITTED ON THE SHOW GROUNDS, EXCEPT THOSE ENTERED IN THE 4-6 MONTH PUPPY COMPETITION.**
11. There shall be no drilling nor intensive training of dogs on the show grounds.
12. Confirmation of entry and schedule of judging time will be sent to the address on the Official AKC entry form after the closing date. If an exhibitor has not received a copy of the schedule within seven days of the show, please contact the Show Secretary.
13. An **AGENT** is a person 18 years or older, other than an owner or co-owner, designated by the owner or co-owner to be handler of, and responsible for, the dog at the show. Agents' names may be followed by the initials which represent their AKC-recognized professional group affiliation or certification. Persons seeking the services of such an agent should familiarize themselves with the requirements for professional group membership or certifications.
14. Trophies and prizes will be awarded in the judging ring to the person exhibiting the dog, who will be considered the owner or his agent. All claims for trophies must be made in the judging ring before the completion of judging. No trophies will be mailed.
15. **DOGS IN VEHICLES DURING HOT WEATHER** - All persons attending this dog show hereby waive any claim for damages against NCA, its Regional Club, Sacramento Valley Dog Fanciers Assn, and/or any of their members, in the event a motor vehicle has to be entered to rescue a dog from overheating or improperly vented conditions.
16. **Exhibitors should follow their veterinarians' recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.**

Note: Effective 6-28-2023, neutered dogs and spayed bitches are allowed to compete in all single-entry non-regular classes at independent specialties. Full AKC registration is required for all entrants in conformation classes (not limited registration).

- Best Veteran Dog and Best Veteran Bitch will be judged before Best of Breed competition.
- VN - Holding NCA Versatile Newfoundland title (CH, CD, DD and WRD).
- Working - Holding NCA Water Dog WD or Draft Dog DD title.

BEST OF BREED COMPETITION

The following categories of dogs may be entered and shown in Best of Breed or Variety competition: Dogs that are Champions of Record, or Dogs which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the day of the show where a dog completed the requirements for a championship according to the owners' records. Winners of the above Non-Regular Classes may also compete in the Best of Breed Competition, provided that they are undefeated in any classes at this show.

GRAND CHAMPION SELECT DOG AND SELECT BITCH

At the judge's discretion, Grand Championship points may be awarded to: Best of Breed, Best of Opposite Sex, Select Dog, and Select Bitch. Dogs eligible for GCH competition are Champions competing in BOB, move-ups to BOB, and champions that win non-regular classes and become eligible for BOB. Altered or spayed CH Veterans are eligible at independent specialties. WD and WB are not eligible.

OWNER-HANDLED BEST OF BREED

This event qualifies for the AKC National Owner-Handled Series (NOHS). Exhibitor MUST check the Owner-Handled checkbox on the entry form to be eligible. See information on Page 6.

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

STUD DOG CLASS: For Dogs and two of their Get. Stud Dogs must be entered in Stud Dog Class and must be shown in the ring with their Get. Get only to be judged, based upon the merits of the Get. The get must be entered in one of the Regular or Non-regular conformation classes above. The Stud Dog need not be intact.

BROOD BITCH CLASS: Same as Stud Dog, substitute "Brood Bitch" for "Stud Dog" and "produce" for "get."

BRACE CLASS: For two Newfoundlands with one common owner, to be shown by one or two handlers.

As the judge's decision in the Stud Dog, Brood Bitch, and Brace classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged First in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.

National Owner-Handled Series



■ REMEMBER TO CHECK THE "OWNER-HANDLED" CHECKBOX ON BOTTOM OF ENTRY FORM.

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS.

Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.

Professional handlers*, household members and current assistants** to professional handlers may not exhibit the dog in any NOHS competition during the entire show. For a detailed description of the National Owner-Handled Series, please visit the AKC website NOHS pages at:

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

* Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

** A current assistant is defined as anyone employed by a professional handler on a full-time basis or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.

Four-to-Six Month Puppy Competition

Judge: Mr. Kim Griffith

SPECIAL CLOSING DATE: OCTOBER 20, 2023 at 9:00 PM.

Open to all Newfoundland puppies that are (4) months & under (6) six months of age on the day of the show. The class is not divided by sex, and there will be a selection of Best of Breed Beginner Puppy and Best of Opposite Sex to Beginner Puppy.

- ◆ An AKC registration number or litter number will be required for entries of an AKC recognized breed or Miscellaneous breed.
- ◆ A foreign born dog may enter this class if they are registered in the country of origin.
- ◆ Dogs are required to be vaccinated (including rabies) in accordance with their veterinarian's protocol in order to avoid inadvertent transmission of illness by/to puppies not yet fully immunized.
- ◆ Entry Fee: \$20.00 per puppy. Use the Official AKC Entry Form from the premium list to enter. Indicate "4-6 mo. Puppy" on the entry form under "class".
- ◆ **SPECIAL CLOSING DATE IS OCTOBER 20, 2023 at 9:00 PM for the Beginner Puppy Competition.** Note that entries received after the specialty show's closing date will receive an entry confirmation, but may not receive a Judging Schedule, and may not be included in the Specialty Show catalog.
- ◆ All applicable rules found in Rules Applying to Dog Shows will govern the conduct of this competition unless these regulations state otherwise. AKC Rules in Dealing with Misconduct will be applicable to any person and dog entered at this competition.
- ◆ Exhibitors should plan on opening the mouth of their puppy for the judges.
- ◆ No puppy can be judged if it is bandaged, taped, glued, stitched anywhere including ears or tail. These dogs will be excused from judging, but, at judge's discretion, may return to the ring to be judged after the tape or bandage is removed.
- ◆ Breed standard disqualifications such as color, height, weight or dentition shall not be a point of consideration in the judging process for this Best Beginner Puppy in Breed Special Attraction.
- ◆ Professional handlers are not allowed to exhibit in this competition. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.
- ◆ Judging will not run concurrently with the regular class judging.

Qualifying scores not required for awards in the non-regular classes. "Dog" means either sex. Please specify dog's jump height on the entry form for those obedience classes which have jumps. Dogs will be sorted by jump height and run in DESCENDING order starting with 36".

CLASS TRANSFERS: ("Move-Ups") Obedience and Rally exhibitors, upon completion of a title after close of entries, may transfer their entry from one obedience class to another obedience class (or one rally class to another) provided the class is scheduled, the judge is available, and the class has not reached its limit. The Event Secretary must be notified in writing at least 30 minutes prior to the start of the trial. Requests will also be accepted prior to the trial.

BITCHES IN SEASON are not permitted to compete in Obedience or Rally Trial classes. If a female is withdrawn from competition for coming into season and the Event Secretary is notified no later than ½ hour prior to the start of the first class, then the club will refund the entry fee. **A processing fee of \$10.00 per entry will be retained.**

RALLY: The Rally Ring size will be approximately 40' x 60'. Rally Exhibitors: Please specify your dog's jump height for Rally Advanced, Excellent and Master classes. Classes will be organized in DESCENDING order starting with 16".
