The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- 5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.

CANADIAN/Foreign exhibitors must make fees payable in U.S. FUNDS. Secretary assumes no responsibility for cash sent through the mail. Tabulate carefully. Due to cost of processing, no refunds of \$15.00 and under will be made.

Entries Close at Secretary's address at 12:00 Noon (PDT), WEDNESDAY, OCTOBER 11, 2023, or when the numerical limit has been reached, after which time entries cannot be accepted, canceled, or substituted, except as provided for in Chapter 11, Section 6 of the Dog Show Rules. Acknowledgment of entries will be made as soon as practicable with email.

Entries will NOT BE ACCEPTED that are telegraphed, telephoned, unsigned, not on an official AKC entry form, downloaded and/or photocopied without Agreement and Rules on the reverse side. Entries received without fees will not be accepted. No conditional or phone entries will be accepted.

Post Dated Checks, Returned Checks and Declined Credit Cards do not constitute a valid entry fee. The Secretary will add a \$25 collection fee to the amount of each returned check or declined card. Subsequent returned checks or declined cards from the same exhibitors may result in their being put on a CASH ONLY basis

An AKC Recording Fee of \$.50 first entry only and an AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. An AKC Recording Fee of \$3.50 will be required for each first entry and \$3.00 for each additional entry in any Licensed or Member Club Rally Trial. All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions.)

Each Owner and Agent listed on the entry form and/or individual responsible for the dog at a show is bound by the Certification and Agreement on the front and back of the entry form regardless of who may have completed & submitted the entry form.

As specified in Chapter 12, Section 4 of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

Dogs May Arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

Class Cash Prizes will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that breed is over, and the Secretary advised at once. The Secretary and show-giving Club disclaim any liability for cash prizes after the judging of the breed is over.

Judges Will Not Wait for Any Dog Holding Up a Class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

All Dogs Present must be held on leash or confined to their crates except when being judged or when in the exercising ring.

It is expressly understood that exhibitors, alone, are responsible for the behavior of their dogs/children. Any exhibitor whose dogs and/or children create unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such cases, no refund on any fees paid will be made.

No gasoline or diesel generators are permitted inside any building or within 100 feet of any tent in which this dog show is conducted. No pens, crates, or grooming tables within 20' of any ring.

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Event Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the event, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the event before completion, no refund of entry fee will be made. No Refund for Duplicate Entries. Every effort to find all duplicate entries will be made; however, if entry has been processed, no refund will be made.

Errors on Entry Blanks. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.
