# POLICIES AND TERMS

## TO GUARANTEE DATE:

A Bridal Reservation form and a signed Policies contract is necessary to reserve your date and time. In addition, a 25% deposit of the total day of Bridal hair service is also required. I receive several requests per week and the contract ensures your date will be confirmed.

## DEPOSITS

Deposits are non-refundable due to cancelations within 90 days of the scheduled date and you forfeit your 25% retainer. If your date needs to be pushed back and with ample notice, the deposit may be held for the later date. If the service is scheduled within 90 days deposits are non-refundable.

## PAYMENTS AND DEPOSITS

Payments and deposits are to be made to Square space(on my website). Or to my Venmo or CashApp accounts for ease of billing. ALL invoices will be sent via email which is why a valid email address is required. The full balance for the day of service is **DUE ONE WEEK PRIOR TO THE WEDDING DATE. (DUE ON \_\_\_\_\_).**

Any additional services added on the day of your event (if time permits) can be paid for in cash, Venmo or CashApp before the service is performed.

## PRE-WEDDING HAIR TRIALS

Your pre-wedding hair trial is highly recommended about a month prior to your wedding and can be at a location of your choosing. The trial appt consists of a 60 minute session where up to 3 different styles can be tried. Feel free to bring your veil, hair accessories or even your dress with you to this appt. Trials are \$50 and can be paid for in the manners stated above and must be paid for before the service is performed. Additional trials will be billed at the same rate.

## ON LOCATION SERVICES (TRAVEL)

For locations up to 15 miles from Farmington NM there is no additional travel charge added. For locations 16 miles + I do charge a mileage rate of \$0.55 per mile round trip, up to 50 miles. Locations over 50 miles will be discussed and may incur additional fees. All travel fees are **DUE IN FULL AT TIME OF DEPOSIT.**

## HOLIDAY WEDDINGS

For bridal parties requesting services on holidays, there will be an additional \$50 convenience fee applied and due at time of deposit.

## SCHEDULING

Please include the time of your first look photos if any and the time of your ceremony when filling out the inquiry form. This will give me the start time and ensure that we adhere to your day of schedule.

Please be sure all of your bridal party is on time to their appt with clean **DRY** hair. I do not include blow dry time with my bridal services so this is very important for timing.
