### **B. AIPRD Statement of Intention**

Starting in the year 2025 it is the desire of the AIPRD to offer lease(s), for the benefit of the community, for the useful space of the top floor of the recently acquired Guthrie Center.

# C. Specifically, state your proposed use of the space and what portion of the island population would most benefit.

Anderson Island Arts (AIA) began with a small group of like-minded individuals wanting to bring cultural and art events to rural our island community. In 2000 AIA was incorporated as a not-for-profit 501c3 organization. We have proudly served the community and produced and supported many of the community art events that have become island traditions. The mission of AIA is to enrich the lives of people on Anderson Island by making the arts an integral and dynamic part of the community. Our volunteer organization's vision is to grow and sustain a vibrant Anderson Island arts community,

where support of the arts serves as a catalyst for creativity, collaboration, and collective benefit. Our year-round concert series, art shows, writing workshops, and art classes are enjoyed by permanent residents, as well as, residents with summer homes and island visitors alike.

The ultimate mission of AIA is to develop an arts center that will provide an indoor performance center, art gallery, art studios, workshop/classroom space, storage, and accommodation for an Artist-In-Residence. However, the appropriate next step in this wider plan is to locate a suitable office location. AIA Board of Directors is looking for an office space with internet connectivity that will accommodate a desk, small meeting table, file cabinet, and storage closet space of approximately 10' x 8'.

If our request is granted, the office space will serve the community by affording a location where the business of AIA can be conducted. In addition to the regular business of AIA e.g., record keeping, bookkeeping, registration. Events will be scheduled, promoted, and organized from the office.

The AIA board has long thought that AIA would be best served with an office space that will serve as the public face of the organization and where island residents can easily contact us. The office will also serve as an anchor for the organization providing much needed visibility and access between AIA events. The space may also be used to showcase upcoming events along with rotating small-scale artworks.
