The Safeguard American Voter Eligibility (SAVE) Act Would Disenfranchise Millions of Citizens

"While the vast majority of Americans have a birth certificate, tens of millions of married women could not present their birth certificate as proof of citizenship under the SAVE Act, as it does not display their current legal name." The SAVE Act doesn't include proof of name change or a marriage certificate as acceptable proof of identity. This is vital for married women with a birth certificate that does not match their current legal name. However, there are several government agencies to notify when you change your name whether by marriage, divorce or court order.

Notify the Social Security Administration (SSA) early. Other agencies learn of name changes through the SSA. Take responsibility. If you or someone you know has a name different than that on their birth certificate, Operation Wildfire recommends that the documentation be fixed now.
