- Donald Trump announced an aggressive and ambitious plan to undo what he characterized as the suppression of free speech in the U.S. if he is elected president in 2024. The Right to Bear Arms: The Second Amendment

- Kamala Harris has made preventing gun violence a key pledge, and she and Governor Tim Walz both gun owners often advocate for tighter laws. If elected, the Vice President promises to ban assault weapons and high-capacity magazines, and require universal background checks for gun sales. As a 2019 presidential primary candidate, Kamala Harris said, "I support a mandatory gun buyback program" for assault weapons. The campaign says that the Vice President has changed her position and does not support mandatory gun buybacks. Abortion and Reproductive Rights: 9th Amendment and Due Process Clause of the 14th Amendment In Roe v. Wade, the Court developed a trimester formula to control the right of the state to intervene in a pregnancy. During the first trimester, the state had no ability to override the discretion of the mother in deciding to end a pregnancy. During the second trimester, the state could regulate abortions to protect the health of the mother, but outright abortion bans were prohibited. During the third trimester, abortion regulations and even bans might be valid because the fetus is viable. The state thus could protect the life of the fetus in this final stage, although any regulation or ban needed to contain an exception for abortions that would be required to

 Vice President Harris supports Congress passing a federal law that would protect abortion rights. As a U.S. senator, Harris opposed anti-abortion bills that would have conferred personhood rights on fetuses.. None of them ultimately passed.

Conversely, Harris championed various bills that would have protected and advanced reproductive rights. In 2019, for example, Harris was a co-sponsor of the Women's Health Protection Act, which would have enacted a federal statutory right to abortion. It also did not pass.  Former President Trump said, if elected, he would not sign a federal abortion ban if that legislation came to his desk. He has long tried to steer clear from supporting national restrictions.

When the Supreme Court overturned Roe v. Wade, the Former President remarked, "The states will determine by vote or legislation or perhaps both. And whatever they decide must be the law of the land," Trump said of abortion rights. "Now, it's up to the states to do the right thing." The Right to Vote: 14th, 15th, 19th, 24th and 26th Amendments

- Kamala Harris supports the John Lewis Voting Rights Act and the Freedom to Vote Act. The Lewis
 legislation would require certain states and counties to get "preclearance" approval from the Justice
 Department or a federal court before changing their rules for elections. The Freedom to Vote legislation is
 broader, setting standards for early voting, mail voting, voter registration and seeks to curb gerrymandering
 and certain campaign finance practices. This legislation would federalize the election process. To read the

Judicial Branch: Article III of the U.S. Constitution

While the original Supreme Court consisted of six justices, its membership varied between five and 10 justices until it was fixed at the current membership of nine after the Civil War. To preserve judicial independence, Justices serve life terms once they have been appointed by the President and confirmed by the Senate. However, a Justice sometimes may voluntarily step down. - Kamala Harris endorses a wholesale restructuring of the Judiciary to include a Constitutional
 Amendment that no former president is immune from prosecution for crimes committed in office, 18year Supreme Court term limits and a binding code of conduct for Supreme Court Justices. Kamala
 Harris also supports breaking the Senate filibuster rules to pass the reforms. She has also indicated
 her support of court packing; specifically, adding six Justices to the Court. To learn more, visit

- Donald Trump believes in fair and independent courts. He has said that he appointed constitutionalist
 judges who interpret the law as written, and he will do so again if voters send him back to the White

Protecting Our Borders: Article IV, Section 4

Article IV, Section 4 of the U.S. Constitution states: The United States shall guarantee to every State in this Union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence. This was to guarantee that each state of the union was protected against invasion by foreign nations, revolutionary forces, drug cartels and uncontrolled (illegal) immigration. - The Vice President has endorsed comprehensive immigration reform, seeking pathways to citizenship
 for immigrants in the U.S. without legal status, with a faster track for people living in the country illegally
 who arrived as children. She hasn't weighed in on whether she would continue key Biden
 administration programs that have allowed more than a million migrants to enter the country. Read

- The Former President said he'll use the National Guard to round up migrants, and said he would invoke the Alien Enemies Act, a 1798 law that allows the president to deport any noncitizen from a country that the U.S. is at war with. President Trump says he also would bring back policies he put in place during his first term, like the Remain in Mexico program and Title 42. Remain in Mexico made migrants wait in Mexico while their asylum cases were heard, while Title 42 curbed immigration on public health grounds. He also seeks to end birthright citizenship for people born in the U.S. whose parents are both in the country illegally.
