What Should You Look For In a School Board Candidate?

Whether you're satisfied with your school board or not, your vote in the next election can be instrumental in helping to shape the upcoming board so that it answers the needs of its parents, students, staff and the taxpayers. In this issue, Operation Wildfire looks at the roles and responsibilities of your school board, and provides things to consider when selecting candidates.

The School Board

As required by the Pennsylvania School Code¹, public school districts are governed by a school board that is comprised of directors who serve terms. In compliance with state and federal laws, school boards establish policies and regulations by which their schools are governed. Act 55 of 2017 now requires school board directors to complete training programs.²

Five key functions of a good school board³ include:

- Set the vision and goals for the district.
- Adopt policies that give the district direction to set priorities and achieve its goals.
- Hire and evaluate the superintendent.
- Adopt and oversee the annual budget.
- Manage the collective bargaining process for employees of the district.

A typical school board meeting will include many business items, such as approving the school calendar, adopting curriculum, overseeing construction and approving contracts with outside vendors.

Selecting School Directors (aka School Board Members)

You, responsible citizen, are standing in a voting booth. Along with other important positions, you see a list of names running for the school board in your district. You scan the list and realize that most, if not all, of the names are unfamiliar. Hmmmm, you think, I have no idea who to vote for. Really, does it matter? It's just the school board.

You're not alone. But there are many good reasons to care. School Directors are the decision makers – they determine the quality of the buildings where our children spend their days; they select the textbooks our children read and the online programs our children log countless hours on. They assess safety procedures during emergencies and choose the bus company that will safely take our children to and from school. They also decide whether or not the superintendent is doing his or her job.

If voting for a School Director *still* doesn't sound like a big deal, try this statistic: Only 10 percent of the voting population shows up to cast a ballot in their local school board elections. While that's unfortunate, there is an upside. Your single vote counts for more than in almost any other election because there is such a low turnout. Let's review what makes a good school board member.

Characteristics of a Good School Board Member

According to Great! Schools.net, here are a few characteristics of a great school board member:

- Participates in setting the vision and goals for the district, and measures the success of the district and superintendent against those goals.
- Communicates their actions to the community. Through public discourse and written reports, great school board members keep the public informed of the district's progress and challenges.
- Works as a team. They collaborate well with others and are respectful of the other board members and superintendent.
- Adopts a fiscally sound district budget. They pay attention to finances and regularly monitor the fiscal health
 of the district.
- Focuses on what's best for all students, implementing policies that ensure success for everyone.

School Director Candidates May Cross-File

There are five School Director positions up for election this year in each Centre County school district. Most candidates will be listed on both the Republican and Democratic ballots.

How is that possible? In July 1972 the state legislature passed Act 171 that allowed school board candidates to cross-file nomination petitions for multiple political parties. The reform argument was that cross-filing served as a mid-point between purely partisan elections and completely nonpartisan elections. In addition, academics maintained that politics and education were separate entities. The desire was to preserve the image of public schools as a unique nonpolitical function of government. Candidates may decide to file as a candidate on both the Republican and Democratic Primary ballots but they are not required to do so.

If a candidate chooses to cross-file, he/she is required to submit two sets of petitions with at least ten signatures from registered Republican voters on one petition and ten signatures from registered Democratic voters on the other. Candidates must recruit a volunteer to circulate a petition for the political party with which the candidate is not affiliated in order to obtain the required signatures from voters in the other party.

While Operation Wildfire has provided the political affiliation of each candidate for reference purposes, we believe strongly that School Director candidates should be committed to doing what's best for all students, parents, taxpayers and staff, regardless of political affiliation.

H.R. 5 - Parents Bill of Rights Act

This bill outlines various rights of parents and guardians regarding the elementary or secondary school education of their children. The bill would require schools to publish educational materials such as catalogs of books kept in libraries and course curricula. Other provisions establish parental rights to request meetings with educators, address school board meetings and review district budgets. The legislation passed the U.S. House of Representatives on March 24, 2023 and is now in the U.S. Senate. Senate Majority Leader Chuck Schumer has said the Republican bill "will not see the light of day" in the Senate."
