Good Afternoon, Mr. and Mrs. Kerr,

Thank you for allowing us to prayerfully consider your appeal. Over the past two days, many of Ryder's and Rory's teachers received and accepted your apologies for the behaviors we detailed in our meeting. All of them expressed their love and appreciation for your boys. After discussing and weighing the impact of the issues we discussed on Friday, we are not going to accept your petition for reinstatement and will move forward with the withdrawal process. In this circumstance, the needs of our staff weighed heavily in this difficult decision.

Mrs. Gilliland has contacted the Folds of Honor representative and Folds of Honor has agreed, in my understanding, to pay for all outstanding tuition and fees that are due on your family's account. Therefore, you should receive a refund for all payments you have made on the account to this point. As you know, there is a two-month penalty that can potentially be waived pending that throughout the withdrawal process and following there is no dissension or discord resulting from the dismissal of your sons. If there are no problems, we want to extend that offer of waiving the two-month penalty. To that end, I believe you can expect to see half of the remaining Folds of Honor funds returned to you before the end of this week and the other half by the fifteenth of November. I will confirm all of this with Mrs. Gilliland tomorrow and we will send you a finalized summary of a refund plan no later than 3:00 PM tomorrow.

Additionally, Mr. Bentley has been looking into the matter of finding out if there are opportunities for Ryder to continue with his CCU coursework. I have asked him to reach out to you tomorrow with those details.

Finally, we will proceed with the withdrawal process by collecting any remaining athletic gear, textbooks, technology, and fees outstanding. I will see to it that we have all personal items from the boys' lockers ready for y'all to pick up at 10:30 AM or between 4:15-5:00 PM. If those times don't work for you, then we will find a more suitable time.

I sincerely hope and pray that in spite of this painful juncture, the Lord will pour out blessings unimaginable on your family in the days to shortly follow. You have two incredible young men, and they will be dearly missed. We hope that you can find a school that will better meet your needs and expectations.
