- Acceptance of gift is to be accepted by the Blaisdell Family National Association, during the waiting period temporary custody of gift item is assumed by the Blaisdell Family National Association.
- 3. Gifts to the Blaisdell Family National Association are tax deductible from taxable income in accordance with the provisions of Federal income tax laws. However, Blaisdell Family National Association board members and volunteers CANNOT, in their official capacity, give appraisals for the purpose of establishing tax deductible value of donated items.
