- WHEREAS,** The Blackfeet Tribal Business Council has been organized to represent, develop, protect, and advance the views, interests, education, and resources of the Blackfeet Indian Reservation, and
- WHEREAS,** Pursuant to the Blackfeet Tribal Constitution, Article VI, Section 1 (e) and 1(g) the Blackfeet Tribal Business Council has the power and authority to manage all economic affairs and tribal affairs of the Blackfeet Tribe, and
- WHEREAS,** The Blackfeet Tribal Business Council has a continuing interest and a duty to ensure that elected officials protect the Treaties and Sovereignty of the Tribes; and,
- WHEREAS,** Tom Rodgers is an enrolled Blackfeet member, and successful business owner, and
- WHEREAS,** Tom Rodgers and the Native American Voters Rights Group Four Directions, Inc. is currently working with Montana Tribes to ensure our members are afforded the opportunity to vote by providing transportation, election information and voter protection at the polls; and;
- WHEREAS,** Tom Rodgers and Four Directions are going to hire and train Tribal Members to help with transportation, voter protection and election information to empower our members and our Tribes, and

Please know as you travel our beautiful land that your Blackfeet brothers and sisters look forward to that autumn day when we will honor you with our own "sinakit."
