2020 Rate Changes

The Cottonwood Water & Sanitation District Board of Directors and the District's management company routinely review the District's financial condition. The District prepares annual budgets and as a part of that process, evaluates the need for rate adjustments. At the November 17, 2019, public meeting, the Board reviewed the District's financial results and projections. The District has experienced rising costs of water supply and wastewater treatment and the District is also experiencing inflationary increases in utilities and labor costs as well as increases in infrastructure supplies, repairs, and maintenance expenses. The District Board seeks to keep rates as low as practical while covering operating costs, ensuring high quality and reliable water delivery and efficient collection and treatment of wastewater.

Water and wastewater rates

The District's rates include a fixed base fee for water and wastewater services and a use fee calculated on customers' monthly metered water consumption. The Board approved a 3% increase in water and wastewater use fees effective January 1, 2020. The water and sewer base fees were not increased. Based on 2019 customer use, the average District residential customer will see a \$1.50 per month increase in their 2020 monthly bills.

Property taxes

A portion of every customer's property tax bill goes to the District to repay District debt. As part of the budget process, the Board of Directors certified the 2020 District debt service mill levy at the November 17th public meeting. The Board of Directors approved a decrease in the property tax mill levy from 14.5 mills to 14.0 mills for property taxes payable in 2020.
