### **REACTIVATION OVERVIEW**

**Eligibility:** Inactive members of a year or more of Krimson Kourts Inc. National Service Organization. Must have a signed resolution on file or become a member under a chapter that has a signed resolution on file.

**Timeline:** The Reactivation packet and fees will be due at the time specified. Payments are to be made via our payment website only. Reactivation forms will not be processed without the submission of fees.

### PARPERWORK REQUIREMENTS

All required paperwork is available via Google Form. A request for paperwork must be submitted to the Membership Committee via email at kkinso.membership@gmail.com. Once the request is received, the paperwork will be sent. Paperwork must be returned to kkinso.membership@gmail.com by the deadline.

All monies will be due with the submission of your Reactivation form. Paperwork will not be processed without payment. Payments will be accepted through our payment website: <a href="www.kkinsoservices.com">www.kkinsoservices.com</a>. Please note that the website includes its own fees in addition to the membership fees.

When making a payment, be sure to put your first and last name and "Reactivation Fee" in the memo section. Failure to provide all information will result in a delay in processing your paperwork. You can only pay for one person at a time. We will not accept bulk payments. All monies paid are non-refundable.

### **PROCESS**

Once confirmation of completed paperwork and the reactivation fee is received, the member will receive a confirmation letter. Reactivated members will be responsible for getting updated with any membership certifications. Additionally, we encourage all reactivated members to join the members-only page located on our website <a href="kkinso.org">kkinso.org</a>.

KKINSO has a membership training classroom where members can get necessary certifications, learn about the organization, and more. You will need a Gmail account. Please be sure to use a professional email.
