

NOTICE TO MEMBERS

The following amendments to the By-Laws of the Hernando County 10-13, approved by the Board of Directors on January 18, 2024, was presented for approval to the Membership at the regular membership meeting on February 14, 2024 where a quorum was present. Prior to the vote, discussion was open to the floor and a motion was made to modify the proposed amendment to Article VII, Section 3 by changing the required number of members for a quorum from 15 to 20. The motion was seconded and passed by unanimous vote.

AMENDMENTS TO THE CONSTITUTION AND BY-LAWS OF HERNANDO COUNTY 10-13 CLUB SUBMITTED BY MEMBER ARTHUR BABCOCK TO THE BOARD OF DIRECTORS ON JANUARY 18, 2024

The Board of Directors by majority vote on January 18, 2024, presents to the general membership for adoption, at the upcoming meeting of February 14, 2024, the following amendments to the Hernando County 10-13 Constitution and By Laws, promulgated on September 14, 1993 and as previously amended on January 9, 2002; January 14, 2004; May 11, 2005 & August 7, 2007 (hereinafter "By-Laws").

The By-Laws are amended as follows:

ARTICLE IV DUES

Section 1 Is deleted in its entirety and replaced with the following
"*Section 1.*

The annual dues shall be as follows:

- (a) \$40.00 per member. \$5.00 initiation fee upon joining
- (b) \$20.00 per Lifetime Member
- (c) Honorary Members shall not be required to pay dues.

Said amounts may be changed upon the recommendation of the Board of Directors and presented to the membership for approval at a regularly scheduled meeting.

ARTICLE VII QUORUM

Section 3. Is deleted in its entirety and replaced with the following
"*Section 3.*

The presence of 20 members at a Regular meeting or Special meeting shall constitute a quorum for the purpose of conducting Club business that requires a general vote of the membership.

Approved by the Board of Directors on January 18, 2024

Ratified by the unanimous vote of the membership at the general meeting of February 14, 2024.
