PRESIDENT'S MESSAGE

November 2025

I wish there was some good news to relay on the status of the city's actions regarding health coverage for all city employees and retirees. What information is available is sketchy at most. The announcement provides little detail except for the replacement of GHI-CBP with a new plan for all in service NYC employees and pre-Medicare retirees who wish to join. This new plan will be jointly administered by Emblem Health and United Healthcare. It is represented that all GHI-CBP benefits will be the same under the new plan except: 1) the Provider Network will increase, both in NYC-Metro Area and more significantly nation-wide; and 2) required Prior Authorization will be reduced substantially. As the saying goes, "the devil is in the details."

As for Medicare retirees, nothing is happening and we will have to wait until the next mayor decides their fate.

Just a reminder, as we come to the end of the year, the annual dues are coming due. Please pay your 2026 dues promptly.

In addition, Bob Concepcion has been diagnosed with leukemia. He can use some spirt (non-alcoholic of course) pick me up. If you have some time Bob would appreciate a phone call.







We are hooking up with the Suncoast 10-13 for the annual "Day at the Races" at Tampa Bay Downs. The date is set




