BUILDING PERMITS

We are aware some people have questions about what requires building permits, you need permits when you put up a fence, new roofs, carports, portable buildings, storage buildings or add additional square footage to your existing home as well as a few other things. Please review your sections deed restrictions as each section of this subdivision has its own deed restrictions. So if you have any doubt about a deed restrictions or the need for a permit please call a board member with your questions.

SPEED BUMPS

DUMPING AT BULKHEAD
