Message from Your HOA President



Happy Spring! It's great to see everyone out working in their yards and helping to maintain the beauty of our neighborhood. I hope the nice weather also brings neighbors outside to socialize with one another. One of the best things about our neighborhood is the sense of community we have created.

Next, I have some HOA business news to share.

Nonpayment of Dues There were a lot of concerns expressed at the HOA's Annual

Meeting in January about homeowners who do not pay their dues. Basically, homeowners who pay are tired of carrying the load for those who don't. How best to address this has been a recurring discussion in my five plus years as president both in the annual meetings and during the Board of Directors'



meetings. Since the 2016 flood, the board had previously voted to use informational efforts to encourage members to pay their dues rather than enforcing the provisions called for in the Woodlands' Articles of Incorporation and Building Restrictions. While these efforts were initially effective, there was no notable increase in the number of dues-paying members from 2021 to 2022. Therefore, as a first step, the HOA's Board of Directors voted to enforce the late fee provision called for in the Woodlands' Articles of Incorporation and Building Restrictions beginning April 1, 2023. Homeowners who have not yet paid their 2023 dues were mailed a letter on March 13, 2023 stating that HOA membership and dues are mandatory. If the \$50 dues are not paid on or before March 31, 2023, a late fee of \$15 will be added to the amount due. An additional late fee will be charged every time an invoice for nonpayment must be mailed by the HOA, which the board voted to do on a quarterly basis at this time.

Speeding

Another frequent complaint and/or concern I receive is about cars speeding through the neighborhood. We have tried to get speed bumps or other speed deterrents installed, but the City Parish did a traffic study and said we didn't have enough traffic to warrant it. With an increase in dues collection, the board hopes to provide more hours of the off-duty Sheriff's patrolman in our neighborhood to help stop some of the speeding, as well as assist with other issues.

New Vice-President

In other news, the board approved Calvin Moore as the HOA's Vice-President after the January Annual Meeting. I know you all join me in welcoming him to his new position.
