AFFIDAVIT OF ROGERIO CHAVES SCOTTON

STATE OF FLORIDA COUNTY OF PALM BEACH

I, **Rogerio Chaves Scotton**, being duly sworn, depose and state as follows:

1. **Personal Information**:

My mail address is at 160 W Camino Real #102, Boca Raton, FL 33432, with a secondary residence located at Rua Uberaba, 55, Grajaú, Apt. 405, Bloco 4, Grajaú, Rio de Janeiro, RJ, Brazil.

2. Role in the Transaction:

- o I have been working with **Marco Antonio Bruno Da Silva** in Brazil, assisting him with contracts, document preparation, translation, and understanding U.S. laws and business practices.
- o I invested alongside Mr. Da Silva in the purchase of the aircraft in question.

3. Threats and Malicious Conduct by Defendants:

- o I was directly threatened by Mr. Nikolaos Kyriakopoulos ("Nick"), owner of Logos Aviation, who stated that if I pursued litigation, I could be harmed.
- During a phone call where I demanded the return of our deposit due to fraud, Mr.
 Kyriakopoulos accused me of extorting him for money.

4. Fraudulent Misrepresentation:

- o Mr. Kyriakopoulos misrepresented that the aircraft being sold was operational and equipped with two Rolls-Royce engines. Upon investigation, we discovered the aircraft in a different location than represented (not at Logos Aviation in Fort Lauderdale), missing both engines, with broken windows and other significant defects.
- Despite these findings, Mr. Kyriakopoulos laughed and ridiculed our concerns, repeatedly stating that we had no recourse as we are from Brazil.

5. Defamation and Further Threats:

- When I confronted Mr. Kyriakopoulos about the fraudulent sale, he claimed that Mr. Da Silva was a drug dealer. I informed him that even if such claims were true (which I do not believe), it would not entitle him to keep funds obtained under fraudulent pretenses.
- Mr. Kyriakopoulos responded with vague threats, implying harm if we pursued legal action.

6. Contractual Breach:

- o I contacted Mr. Mark Daniels of Aerovision, who alleged that the contract was void because Mr. Da Silva failed to make a \$1,000,000 deposit as required.
- When I questioned Mr. Daniels about the contract's representations, specifically the claim that the aircraft was operational and equipped with Rolls-Royce engines, he failed to provide any explanation or justification.
- Furthermore, the registration details of the aircraft mentioned in the contract did not match the aircraft inspected at another airport.

7. Dilson Prado da Fonseca's Involvement:

 Mr. Prado initially presented himself as a licensed aircraft broker but later claimed he was only an aircraft washer and that his sole role was introducing Mr. Da Silva to Logos Aviation.

8. Attempts to Resolve the Issue:

- o I personally sent notices of intent to all defendants, providing them 14 days to resolve the matter and refund the deposit.
- None of the defendants acted in good faith or responded appropriately to the notices.

9. Pattern of Fraudulent Behavior:

- In my investigation of court records in Dade, Broward, and Palm Beach counties, I uncovered numerous lawsuits against Logos Aviation and its owners, showing a long history of fraudulent conduct and damage to individuals.
- Logos Aviation has countless negative reviews, poor credit history, and a pattern of federal crimes that have harmed many others.

10. Federal Complaints Filed:

• I filed a complaint with the **FBI**, highlighting the fraudulent practices and requesting an investigation into the conduct of Logos Aviation and its owners.

11. Purpose of the Affidavit:

• This affidavit is submitted in support of the legal claims against the defendants, demonstrating the ongoing harm and fraudulent behavior that necessitates immediate legal intervention to prevent further damage to others.
