Re: False and Malicious Reports Filed by Mark Davis Against Mr. Marco Antonio

Bruno Da Silva

To Whom It May Concern:

This letter is submitted on behalf of Mr. Marco Antonio Bruno Da Silva, a Brazilian

citizen who has been the target of false and malicious allegations made by Mr. Mark

Davis of Aerovision LLC. These actions appear to be in direct retaliation for Mr. Da

Silva's intention to file a civil lawsuit against Mr. Davis and other associated parties

for fraud, misrepresentation, and other violations related to a failed aircraft

transaction.

**Background** 

Mr. Da Silva was recently notified by the U.S. Embassy in Rio de Janeiro to attend a

second visa interview, despite already holding a valid and approved visa. It has come

to our attention that Mr. Davis has maliciously filed a criminal complaint alleging baseless accusations of terrorism and threats under Florida Statutes § 836.10 and Federal Title 18 statutes, which are entirely false and defamatory.

We believe these allegations are part of a deliberate attempt to:

Intimidate Mr. Da Silva and obstruct his pursuit of legal remedies in the United States. Retaliate against Mr. Da Silva for uncovering and preparing to file a civil RICO lawsuit that implicates Mr. Davis, Logos Aviation, and others in a fraudulent scheme involving a \$700,000 deposit for a Gulfstream G-IV aircraft.

Evidence of Retaliation and Fraud

Mr. Da Silva has substantial evidence supporting his claims of fraud, including:

Misrepresentations in the contract regarding the aircraft's condition and operability.

Proof of payment via wire transfer to Logos Aviation LLC and Aerovision LLC.

Videos, photos, and investigative findings showing the aircraft in disrepair and missing engines.

Records of Defendants' attempts to manipulate the situation by offering different aircraft and refusing to refund the deposit.

Conversely, Mr. Davis's allegations lack any factual basis and constitute a violation of both state and federal laws, including but not limited to:

Florida Statutes § 837.05: Filing a false police report.

Florida Statutes § 836.05: Extortion and threats.

18 U.S.C. § 1001: False statements to federal authorities.

Demand for Immediate Action

We respectfully request that your office:

Investigate the malicious and false complaint filed by Mr. Davis against Mr. Da Silva. Provide assurance that Mr. Da Silva's lawful rights, including his visa status and ability to pursue legal recourse in the United States, will not be infringed by these baseless allegations.

Hold Mr. Davis accountable for any violations of law stemming from his retaliatory actions.

Our client remains committed to cooperating fully with any legitimate inquiries but will not tolerate abuse of legal and administrative processes designed to intimidate or harm his reputation.
