COMES NOW the Plaintiff, Rogerio Scotton, as founder and representative of Legal Help 4 You LLC, and respectfully submits this Notice of Intent to File an International Complaint against the Defendant, Alexandre de Moraes, for ongoing

and systematic violations of international human rights law, in accordance with international conventions and the Universal Declaration of Human Rights.

1. PURPOSE OF THIS NOTICE

This Notice serves to inform the Court and all relevant U.S. authorities—including the Department of Justice, Department of State, and affiliated agencies—that the Plaintiff intends to file formal complaints against Justice Alexandre de Moraes with the following international human rights bodies:

Inter-American Commission on Human Rights (IACHR)

United Nations Human Rights Committee (UNHRC)

International Criminal Court (ICC) (subject to jurisdictional acceptance)

United Nations Office of the High Commissioner for Human Rights (OHCHR)

Organization of American States (OAS) Special Rapporteur for Freedom of Expression

2. GROUNDS FOR INTERNATIONAL ACTION

Plaintiff alleges that Defendant, in his official capacity as a Brazilian Supreme Court Justice, has committed gross and systematic violations of:

The American Convention on Human Rights (Pact of San José, Costa Rica)

NOTICE OF INTENT TO FILE INTERNATIONAL COMPLAINT

The International Covenant on Civil and Political Rights (ICCPR)

The United Nations Universal Declaration of Human Rights (UDHR)

The Convention Against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment

Customary international law principles protecting freedom of speech, political participation, due process, and physical integrity.

3. ALLEGED VIOLATIONS INCLUDE BUT ARE NOT LIMITED TO:

Arbitrary imprisonment and prolonged pre-trial detention of peaceful protesters;

Censorship and cancellation of social media accounts of political dissidents, using U.S.-based platforms;

Revocation of presidential pardons without legal basis (e.g., Daniel Silveira case);

Disproportionate sentencing (e.g., Débora Rodrigues dos Santos – 14 years and R\$35 million fine);

Retaliation against elderly individuals, including Iraci Nagoshi (77), ordered back to prison post-surgery;

Use of legal authority to unilaterally investigate, prosecute, and convict without impartial judicial process;

Public refusal to comply with U.S. sanctions and declarations implying the U.S. government is aiding criminal conspiracies.

4. JURISDICTIONAL JUSTIFICATION

As the alleged abuses:

Directly impacted individuals residing in or using U.S.-based services and platforms (e.g., Twitter/X, YouTube, Meta, Rumble);

Were transmitted through U.S. telecommunications infrastructure;

Involve the misuse of international cooperation treaties and retaliation against individuals seeking asylum or protection in the U.S.;

...the Plaintiff asserts that these matters raise questions of universal jurisdiction, treaty obligations, and U.S. foreign policy interests.

5. REQUEST FOR RECOGNITION AND PROTECTION


Plaintiff respectfully requests that this Court acknowledge the seriousness of the intended international complaint and recognize its relevance to the broader scope of this case. The Plaintiff may further seek coordination with international human rights legal experts and organizations and requests that the Department of Justice be advised accordingly.


