U.S. Lawsuit Filed Against Brazilian Supreme Court Justice Alexandre de Moraes for Human Rights Violations

Plaintiff Demands U.S. Department of Justice Criminally Indict Moraes Under Global Magnitsky Act

Boca Raton, FL – Legal Help 4 You LLC, led by legal advocate and founder Rogerio Scotton, has officially filed a lawsuit in U.S. Federal Court (Southern District of Florida) against Brazilian Supreme Court Justice Alexandre de Moraes. The complaint calls for a **criminal investigation and indictment** by the U.S. Department of Justice for **systematic violations of international law, human rights abuses, and the defiance of U.S. legal authority**, including contempt of the **Global Magnitsky Human Rights Accountability Act**.

“This is not about politics. This is about the law,” said Rogerio Scotton. “We are not taking sides with the left or the right. We are taking the side of truth, accountability, and justice—regardless of who it affects.”

THE ALLEGATIONS

DOCUMENTED HYPOCRISY AND POLITICAL MANIPULATION

Before aligning with the current Brazilian administration, **Alexandre de Moraes** publicly stated:



“O PT é uma organização criminosa. O governo do Lula foi o mais corrupto da história.”
(*“The Workers' Party [PT] is a criminal organization. Lula's government was the most corrupt in history.”*)

Similarly, **Brazil's Vice President Geraldo Alckmin** declared in 2017:

“Lula is the portrait of a party without ethics, involved in corruption. Society demands justice.”

Now, both figures stand united in power—criminalizing dissenters who express the same views they once shouted into microphones.

“This lawsuit exposes a simple truth: when Justice Moraes was targeting the left, he called them criminals. Now that he's aligned with them, anyone who disagrees is treated like a **criminal**,” Scotton said.

WHY FILE IN THE UNITED STATES?

The lawsuit demands:

- **Criminal investigation and indictment** of Alexandre de Moraes under the Global Magnitsky Act and Torture Victim Protection Act.
- **Referral to U.S. authorities** (Department of Justice, State Department, and Homeland Security) for diplomatic, legal, and human rights sanctions.
- **Immediate protections for U.S. citizens and residents** targeted through coordinated disinformation, censorship, or political intimidation via U.S.-based social media platforms (Meta/Facebook, YouTube, Twitter/X).
