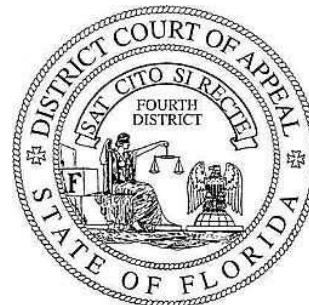

24 Appeal of Florida, Fourth District, the trial court's Final Order of Dismissal, rendered
25 on or about May 14, 2025, which dismissed Plaintiff's case in its entirety.

1 Said order was entered after a hearing held over Plaintiff's prior written objection,
2 while the original judgment giving rise to this case remains pending on direct appeal

4 violates fundamental due process, and that multiple filed motions remain undecided on
5 the record.

8 The nature of the order appealed is a final appealable order of dismissal with prejudice.
