By faith we understand that the universe was created by the word of God, so that what is seen was not made out of things that are visible. Hebrews 11:3

For by him all things were created, in heaven and on earth, visible and invisible, whether thrones or dominions or rulers or authorities—all things were created through him and for him. Colossians 1:16

4. FAITH: We believe faith is the cornerstone of our relationship with Jesus and without faith it is impossible to believe God.

Trust in the Lord with all your heart, and do not lean on your own understanding. In all your ways acknowledge him, and he will make straight your paths. Proverbs 3:5-6

For truly I say to you, if you have faith like a grain of mustard seed, you will say to this mountain, 'Move from here to there', and it will move and nothing will be impossible for you. Matthew 17:20

Therefore, since we have been justified by faith, we have peace with God through our Lord Jesus Christ. Through him we have also obtained access by faith into this grace in which we stand and we rejoice in hope of the glory of God. Romans 5:1-2

Faith is the substance of things hoped for and the evidence of things not seen. Hebrews 11:1

5. SALVATION: We believe by grace, through faith in Jesus, we are saved; "born again".

For it is by grace you have been saved, through faith and this is not from yourselves, it is the gift of God. Ephesians 2:8-9

But to all who did receive Him, who believed in His name, he gave the right to become children of God, who were born, not of blood nor of the will of the flesh nor of the will of man, but of God. John 1:12-13

For God so loved the world that He gave His only Son, that whoever believes in Him shall not perish but have eternal life. John 3:16

For the wages of sin is death, but the free gift of God is eternal life in Christ Jesus our Lord. Romans 6:23

6. IDENTITY: We believe God identified us when he created us in his image and likeness and by calling us His people.

Know that the Lord is God. It is He who made us, and we are His people, the sheep of His pasture. Psalm 100:3

I knew you before I formed you in your mother's womb. Before you were born, I set you apart. Jeremiah 1:5

For we are God's workmanship, created in Christ Jesus to do good works, which God prepared in advance for us to do. Ephesians 2:10

Just as each of us has one body with many members, and these members do not all have the same function, so in Christ we who are many form one body, and each member belongs to all the others. As part of the body, you are set apart and you have unique purpose within the body of believers. Romans 12:4-5

So God created mankind in His own image, in the image of God he created them; male and female he created them. Genesis 1:27

7. GIFTS: We believe God has placed physical and intellectual gifts, and talents in every person and we believe God can empower us with spiritual gifts as well. A gift opens the way and ushers the giver into the presence of the great. Proverbs 18:16

Each of you should use whatever gift you have received to serve others, as faithful stewards of God's grace in its various forms. 1 Peter 4:10

We have different gifts, according to the grace given to each of us. If your gift is prophesying, then prophecy in accordance with your faith. Romans 12:6

8. WORSHIP: We believe worship is a continuous act of honoring and glorifying God in spirit and truth.

I will praise you, O Lord my God, with all my heart, and I will glorify your name forevermore. Psalm 86:12

Sing praises to the Lord, for he has done gloriously; let this be made known in all the Earth. Isaiah 12:5

Ascribe to the Lord the glory due his name; bring an offering and come before Him. Worship the Lord in the splendor of holiness. 1 Chronicles 16:29

Therefore let us be grateful for receiving a kingdom that cannot be shaken, and thus let us offer to God acceptable worship, with reverence and awe. Hebrews 12:28

9. PRAYER: We believe that prayer is constant communication with God and an act of worship in supplication, thanksgiving, adoration and confession.

I call on you, my God, for you will answer me; turn your ear to me and hear my prayer. Psalm 17:6

The Lord is at hand; do not be anxious about anything, but in everything by prayer and supplication with thanksgiving let your requests be made known to God. Philippians 4:5-6

Therefore I tell you, whatever you ask in prayer, believe that you have received it and it will be yours.

Mark 11:24

Continue steadfastly in prayer, being watchful in it with thanksgiving. Colossians 4:2

As a private Christ-centered educational entity, admission to Cohutta Arrows is a privilege rather than a right. We reserve the right to refuse admission to any family we believe may cause disruption to the mission, vision, and values of our school, our community and the spirit that is omni-present among the families involved in Cohutta Arrows Kingdom Academy. It is vital that each family is fully supportive of the mission and vision of Cohutta Arrows Kingdom Academy Ministries, therefore, we require a partnership amongst our students and families.

### **Certification**

While it is not required under the Georgia Department of Education for private institutions, ALL academic instructors at Cohutta Arrows Kingdom Academy hold a degree and are certified through GACS with educational or ministry experience.

### **Accreditation**

It is not required by the State of Georgia Department of Education, nor by the Federal Department for Education that private schools be accredited, nor is there any registration or licensing with the state or federal departments. We consider this a true blessing. This allows Cohutta Arrows to look past bureaucracy that public schools are placed under and the freedom to teach ALL curriculums from a Biblical standpoint. We are official members of GACS, Georgia Association of Christian Schools, as well as AACCS, American Association of Christian Schools. We believe these organizations hold us accountable. We are seeking full accreditation in March 2026 during the 2025-2026 school year.

The administration reserves the right to amend this handbook whenever necessary. Additional instructions may be announced at any time. This handbook does not serve to contractually bind Cohutta Arrows Kingdom Academy Ministries in any way.



## **Admissions & Finances General School Information**

### **School Operating Hours**

Our operating hours are 8:00 a.m. to 3:00 p.m. Monday through Friday on every day of the instructional calendar. Doors will NOT open until 8:00 a.m. No exceptions!

Our day begins with worship and prayer starting at 8:15. Worship & Prayer time are NOT optional. This is the most sacred part of our school day and should not be treated as an extended time for arrival. Our school day begins at 8:15 and ends at 2:35. You cannot drop off your child(ren) any earlier than 8:00 a.m. unless you have made us aware of an unusual circumstance. Hybrid students will need to abide by their agreed scheduled time.

### **Calendar**

According to the Georgia Department of Education, public and private, as well as homeschool students are required to fulfill "180 days of school, or the equivalent of", every 12-month calendar year. The official academic school calendar will be released in the spring.

### **Daily Schedule**

Each class's schedule will vary and will follow a different schedule. Your child's teacher will provide you with an exact daily schedule and the school provides a monthly newsletter for special events and updates.

### **Arrival & Departures/Dismissal Procedures**

Students may begin to arrive at 8:00am. A student arriving between 8:00-8:30 am should be dropped off in the school car rider line. All students will report to the worship room. In the event a child arrives after 8:30 am, the student will need to check-in at the front office and report to worship.

**Traffic for Drop-off:** All students being dropped off in grades K4-12th grade should use the morning car rider line for drop-off. Drivers should pull into the south parking lot and enter the car line. A staff member must be present before your child can exit the vehicle. Drivers should then continue around the back of the building and exit through the north parking lot. All drivers should remain aware of the students walking throughout the parking lot. If a parent/guardian desires to park and walk a student in, they will need to park in the south parking lot and use the crosswalk to assist their child into the building.

All students will be dismissed at 2:30 pm. Checkouts will not be permitted after 2:15pm. Should your child be riding home with another student, all changes need to be

documented and communicated with the front office prior to 2:00 pm. In the interest of safety, Cohutta Arrows will not allow a student to be released to anyone other than the individuals listed on the MySchoolWorx pick-up list. We reserve the right to ask for identification from anyone we do not recognize.

### **Student Drivers**

Students who drive themselves and possibly their siblings to school should park their vehicle in the south church parking lot, closest to the school's drop-off line, during school hours. Student drivers and their siblings must use the crosswalk to enter the school. No student should be walking through the parking lot. For afternoon dismissal, our staff will allow those students to exit the building and have them go directly to their vehicles. Student drivers remember the following expectations:

- Loitering before or after school is not permitted.
- While on campus, students should not be playing loud music.
- Reckless behavior in or around vehicles is not permitted.
- Students are not allowed to ride with other students without documented permission submitted by the parent to the school office.
- Students may not go out to their vehicles during the day without a pass from an administrator.
- Students must have a parking pass within the first two weeks of school, or within two weeks of the student receiving his or her driver's permit. In order to obtain the parking pass, the student must provide the office with a copy of the student's driving permit and a copy of the student's insurance card. The student will owe a \$25.00 fee for the parking pass per academic year. All cars in the parking lot must have a pass on the driver's side windshield at all times.

### **Parents & Visitors**

Cohutta Arrows Kingdom Academy requires a partnership with every family. We will always encourage and promote parental participation. At Cohutta Arrows Kingdom Academy, parents play an important part in the educational process. Parents should remember that their part in their children's education is essential. We do ask every parent and/or visitor, check-in with the front office. We reserve the right to ask for identification before anyone is granted access into the building.

### **Communication**

We want you to always communicate with us in regard to any aspect of your child(ren). You can reach out to us by phone, 706.222.0141, email, Class Dojo, and in-person during a teacher's planning period. Teachers welcome conferences with parents at scheduled times during the school year. To arrange for a private conference, please message your

child's teacher through Class Dojo. If a parent has a specific concern with an instructor, they should adhere to the following procedures:

1. Schedule a meeting with the instructor.
2. If you are not satisfied with the outcome of the meeting, contact the front office to schedule a meeting with an administrator.
3. In the event you still have concerns, please request a meeting with the Board of Trustees through a written and sealed letter submitted to the front office.

## **ADMISSIONS & ENROLLMENT**

The admission and enrollment process contains 4 steps: apply, interview, notification and lastly, enrollment. The specific details of this process is found in the application packet.

Applications can be submitted beginning November 1st of every calendar year for the following school year. We will begin enrollment after the interview portion of the application, which begins in January. The re-enrollment process for current Cohutta Arrow's students begins in February.

The administrators and Board of Trustees of Cohutta Arrows Kingdom Academy Ministries reserves the right to establish and maintain standards for student's spiritual walk, codes of conduct, dress/attire and academics.

### **Procedures of Enrollment**

Complete all required enrollment forms and submit all required documentation via email or mail. Please see the "Application & Enrollment Steps Form" that is included in the enrollment packet.

### **K4 Program**

Our K4 program utilizes Bible based curriculum, Abeka, and does include kindergarten readiness. We are not licensed by the state of Georgia.

Our K4 program is full-day, 5 days a week: Monday thru Friday, 8:15-2:35. Lunch and snacks must be provided from home. We also do not provide a nap time.

### **Transfer Students**

It is solely the parent/guardian responsibility to withdraw a student from a previous education entity and if the parent is filing homeschool with the state, the letter of intent is the sole responsibility of the parent/guardian. The transcript release form will be required to obtain your child's transcripts from their previous school.

If hybrid students participate in extra-curricular activities with any public education school districts, we are not responsible for decisions of the local school boards.

### **Fees & Financial Responsibility**

All tuition fees include curriculum. Other financial responsibilities may include and not be limited to: personal school supplies, lunch (optional), yearbooks, class photos, field trip fees, class activities and other unforeseen expenses. Please refer to the school website for tuition rates and additional information. All financial policies are stated in the payment plan agreement.

If you're interested in part-time or a hybrid education through Cohutta Arrows Kingdom Academy, please inquire through phone and/or email. We will be happy to share this information with you.

All applications will involve a \$100 application fee per child. This fee is directly used to pay for the MySchoolWorks records account for each child and goes towards the annual accreditation fee. Re-enrollment fee is \$75 per child.

Tuition payment invoices are issued by Quickbooks on the 1<sup>st</sup> of every month. Quickbooks allows a 10-day grace period on payments. Full tuition payments are also accepted. Cash and/or Check payments are also due on the 1<sup>st</sup> of every month. After the 10<sup>th</sup> of the month, a late fee of \$50 will be assessed. If payment is not received by the 20<sup>th</sup> of the following month, the student will be withdrawn. Please communicate all payment questions, issues or any financial hardships with Cohutta Arrows Kingdom Academy Admissions & Financial Department. We will do our best to work with your family to secure your child's Biblical education. Any returned checks will be charged a \$30 fee.

A student will not be re-enrolled in the following school year until all invoices are paid in full from the previous academic school year. Cohutta Arrows Kingdom Academy reserves the right to hold all student records in the event there are outstanding tuition invoices and/or fees.

Cohutta Arrows Kingdom Academy is a Christian ministry, a non-profit 501c3 corporation. We operate strictly off of tuition funds to pay operational costs. When tuition accounts go unpaid, this puts the school's financial responsibilities at risk. The best educational services can be rendered if fixed obligations can be met with fixed resources. We understand there are unexpected changes that can occur in your financial situation. If this occurs, we want to help as much as possible. Regardless of your current financial status, it is the responsibility of the person or persons who sign the financial agreement to submit payment.

We offer 2 billing options when paying tuition: an annual option where all tuition is paid by June 1st or a monthly option where your tuition is billed over 10 or 12 months and is due on the 1st of each month beginning in June.

### **Financial Aid & Fund Raising**

As Cohutta Arrows Kingdom Academy grows, we are believing God for ways to offer financial scholarships and grants to families who need assistance. Cohutta Arrows Kingdom Academy Ministries is an official non-profit educational entity. Please be in prayer with us. We pray God will rain down financial blessings on this school in order for us to provide your child the best Kingdom education we can offer and financial aid where needed.

Cohutta Arrows utilizes fundraising promotions during the academic year. Any monies raised through a school fundraiser may only be used for the specified fundraising item or event, per our 501c3 non-profit legal agreement with the IRS.

Independent Fundraising: No parent or student may use the name or the school on any radio, television, social media or publication without prior authorization from the administration to gain personal funds.

### **Breakfast, Lunch & Snack Policies**

Due to our current facility, we cannot offer a food program. Please send your child with lunch, snacks and breakfast, if they're arriving early. There will be opportunities to order lunch from restaurants nearby three times a week. We will communicate the opportunities in a timely manner through a Google form and you will pay for lunches by cash, check or Venmo. There is a microwave provided. Please send items to be heated in a microwavable safe container. Students below second grade do not have permission to use the student microwave. Lunch periods are only 35 minutes. Please keep this in mind when preparing your child's lunch.

Utensils, bowls, plates, etc will need to be sent with the student's lunch. The school cannot provide these items on a regular basis.

Students are not permitted to order lunch through GrubHub, UberEats, etc and have it delivered. This is a breach in our security policy.

## **Health Policies**

### **Vaccines**

We strongly believe that a child's health and vaccine(s) decision is a personal freedom and the decision should be left up to the parent/guardian of each child. Therefore, as we do not require proof of vaccination status, we do have to keep a copy of your vaccination record on file required by the Georgia Department of Education and the Georgia Department of Health. Or, we can provide you with a religious exemption affidavit.

### **Health & Wellness Policy**

We do ask that if your child is ill or running a fever, please allow them to stay at home to limit the spread of sickness to others. Any temperature equal to or greater to 100.4 F, is considered a fever. Students must be fever-free for 24 hours and without the aid of a fever-reducing medication in order to return to school.

If your child(ren) gets sick while at school, we will notify parents/guardians immediately.

A student is unable to participate in any physical activity, must have a note from home or a doctor's note to excuse participation.

IF a minimum of 40% of our student body and faculty become ill, Cohutta Arrows has the right to be closed for a few days to stop the spread of sickness and allow healing to take place.

### **Asbestos**

Cohutta Arrows resides in the new addition of Salem Baptist Church which was built after 1981.

### **Medications**

Any medications to be dispensed to a child during school hours need to be turned in to the teacher or one of our administrators with our Medication Administration Form before any medication can be distributed to a student. Any request for administration of medicine must include the student's name, description, dosage of medication and the time(s) it is to be given.

No over-the-counter medication will be dispensed to a student without parental consent being given. Over-the-counter medication must be provided by the parent/guardian.

Medical consents and health concerns are filled out in the application/enrollment process. This can be updated through the front office.

Under no circumstances should a student ever be in possession of or share any medication with another student.

In the case of an emergency, the appropriate authorities will be notified, transportation will be provided and if necessary, the student will be transported to the hospital.

Cohutta Arrows Kingdom Academy recognizes that children suffer from health problems. These health problems range from mild to life-threatening in regards to the degree of severity. It is the sole responsibility of the legal parent/guardian to communicate all health problems to the teachers and administration at Cohutta Arrows Kingdom Academy.

## **Student Expectations & Conduct**

### **Technology Acceptable Use Policy & Internet Access**

The school will have WiFi and internet access. Technology will be used at Cohutta Arrows Kingdom Academy. However, it will not be used in excess. We believe technology has its place. Kids can learn in various ways that do not involve the use of daily technology. Students are expected to use technology appropriately and with accordance of our student code of conduct, as well as the following guidelines:

- Electronic devices are only to be used in the classroom for educational purposes under direct supervision.
- Inappropriate use of an electronic device will warrant penalties which may consist of loss of technology privileges and use, up to expulsion, depending on the severity of the infraction.

### **Cell Phone Policy & Other electronic devices**

Students are allowed to have their cell phones on school property. However, we will ask students to keep ALL cell phones in their book bags to limit distractions. Cohutta Arrows Kingdom Academy is NOT responsible and will NOT be liable for any lost cell phone. It will be the student's responsibility to be responsible for such devices. Students are never allowed to have their cell phone/electronic device out and in use during any academic class, worship, Bible and/or lunch. If your child's cell phone is collected due to having it out during school hours, the parent/guardian will be required to pick it up in the front office.

### **Dress Code Standard**

**\*PLEASE read the dress standard flier for more detailed and specific information.**

We do require a dress code standard. We do expect all staff and students to dress modestly and respectfully, as described in the Holy Bible. No clothing should promote, encourage or display drugs, weapons, or graphic symbols/emblems. No clothing should be revealing on any area of the body. We expect children to be clothed that displays dignity and respect to themselves and others. We also expect children to be clothed in a way that displays Christ-like character and integrity.

-A woman shall not wear a man's garment, nor shall a man put on a woman's cloak, for whoever does these things is an abomination to the Lord your God. Deuteronomy 22:5

- Likewise also that women should adorn themselves in respectable apparel, with modesty and self-control...1 Timothy 2:9-10
- Or do you not know that your body is a temple of the Holy Spirit within you, whom you have from God? You are not your own, for you were bought with a price. So glorify God in your body. 1 Corinthians 6:19-20
- Clothe yourselves with the Lord Jesus Christ and do not think how to satisfy the desires of the flesh. Romans 13:14

All t-shirts, collared shirts, long-sleeve shirts, or sweatshirts must be plain or purchased by an approved vendor that contains our logo and/or t-shirt screen print that has been approved. In addition to these vendors, parents do have the option to purchase the shirts and jackets separately through Target, Wal-Mart, The Children's Place, etc. and take them to Accent Embroidery or Advantage Sports to have them made.

Approved shirt/jacket/pant colors: White, Grey, Navy, Green or Black

Approved pants: jeans, khakis, leggings or plain athletic shorts. All shorts must have a minimum of a 5" inseam. Girl's skirts or dresses need to be no shorter than 2" from the knee. Pants, shorts, and skirts may also be purchased by any store of their choice. Girls who chose to wear leggings must have their rear fully covered by a long sweatshirt or tunic.

#### Free Dress Days & Formal Event Dress Code

Dress Code for Free Dress Days should follow these general guidelines:

- No clothing should ever show undergarments.
- No clothing with inappropriate symbols, messages or language.
- Shirts may not be worn tightly or show the chest or bare midriffs.
- Leggings are permitted as long as it is paired with a top long enough to cover the backside. This pertains to biker shorts as well.
- Skirts, dresses and shorts must still meet the normal requirements.
- Hats of student's choice are allowed as long as there are no inappropriate symbols, messages or language.

Students will be required to sign and return a dress code agreement in order to purchase a ticket to the event. The administration reserves the right to ask a student to leave the event and change before returning if the dress code is not followed.

#### Dress Standard Violations

Minor dress standard violations will result in a notification being sent to the parent and will be expected to be corrected moving forward. Major dress standard violations will result in the parent being notified immediately and the parent will be required to bring



the student clothing that complies with the dress standard if there is no replacement in our supply closet. If the student in violation drives their own vehicle, the parent may give permission for the student to drive home and return to school with the correct clothing. Multiple dress standard violations may result in a mandatory meeting between the administrators and the parents/guardians, as well as the student to discuss the importance of following a modest dress standard, in addition to any potential plans of corrective actions.

### **Dress Code for Parents & Visitors**

Parents and visitors that are volunteering at the school and/or school activities are asked to be modest in their dress when attending these functions.

## **Student Conduct**

### **Student Expectations & General Discipline Guidelines**

We expect all students and staff to follow Cohutta Arrows Kingdom Academy policies, procedures, expectations and guidelines. While we do not desire a lengthy list of rules and regulations; we do hold our students to a high standard of conduct. We believe that each student is a son or daughter of the most High King, which makes them part of a royal family and royalty is expressed through noble character. We desire each student to elevate their actions and behaviors to match their Christ-given identity as a beloved son and daughter. We believe it is an honor to attend Cohutta Arrows Kingdom Academy and it is our goal to see each student match that level of honor in their hearts and through the way they carry themselves and treat those around them.

We expect all students and staff to treat one another with honor, respect, as well as the facilities.

We expect all students to give full effort into their academics, relationships with God and others.

We expect all students and staff to remember their manners.

We expect all students and staff to be honest, trustworthy and forthcoming.

We expect all students and staff to uphold moral character and integrity.

### **Disciplinary Actions**

We are aware that we will have to handle certain actions correctively and in those instances our staff will communicate with the parents/guardians to inform them of the situation, how it was handled, and how we can partner together to see the student avoid those behaviors in the future. If certain negative behaviors and actions become habitual or ongoing, our staff will coordinate a meeting with the parents/guardians to discuss further action and any potential plans. All disciplinary actions will be discussed and decided upon by the administrators, and the Board of Cohutta Arrows, if suspension, release or expulsion is necessary. Parents/Guardians will be notified if a disciplinary

action is documented. After the 2nd documented disciplinary action, the student will meet with the administrators, as well as a chaplain or pastor on the Board of Trustees. After the 3rd documented disciplinary action, the student will be discussed with the board to decide on a possible behavior plan, suspension, or expulsion, if necessary.

Instances (included but not limited to) that may result in immediate disciplinary action including suspension or expulsion of the Cohutta Arrows Staff, Administration and/or Board:

## **Prohibited Behaviors & Probation**

### **Fighting**

Fighting will never be tolerated. Imposing or threatening harm to another student by any means of violence. In a situation that involves violence or fighting, all parents/guardians will be contacted. The school administrators will have meetings with both parties to discuss the incident and appropriate consequences.

### **Drugs, Alcohol & Weapons**

As we do believe in abundant grace, Cohutta Arrows Kingdom Academy must maintain a zero-tolerance policy on possessing or distributing any drugs, alcohol, illegal substances and weapons for the safety of all students and staff. We have established policies, procedures, expectations and guidelines that will be observed on a daily basis to ensure maximum safety at all times. Prevention is the key. Your child(ren)'s safety and protection are our number one concern at all times.

### **Inappropriate Use of Electronic Devices**

Engaging in and/or exposing other students to any inappropriate use of electronic devices including pornography, inappropriate or threatening messages, or sharing personal/private information of a fellow student or staff member.

### **Probation**

In the case a student is given a suspension or probation period, the terms and time will be discussed and decided upon by the administrators and the Board of Trustees.

### **Expulsion or Dismissal**

Any student with more than 3 documented disciplinary actions, or a zero-tolerance behavior, will be considered in breach of code of ethics and conduct. Suspension, expulsion and/or release of contract will be determined and decided upon by the Cohutta Arrows Board of Trustees.

## **Policies, Procedures & Guidelines**

The following Cohutta Arrows Kingdom Academy policies, procedures and safety guidelines are first and foremost to ensure the safety and protection of your child, staff members and visitors. Therefore, Cohutta Arrows has a full emergency and operations plan. The content of the various components of the Cohutta Arrows Kingdom Academy Ministries Emergency Plan is intended for the use of the administrators and staff of the school/church to help ensure the safety of all students, staff, and visitors in the event of an emergency.

If you desire more details on our policies, procedures and guidelines, you can request more specific information on safety procedures and protocols, inclement weather, and other policies from our front office.

In the event of inclement weather that causes safety concerns, the Academy will follow Whitfield County Schools in regards to starting delays, early dismissals and cancellations. Parents should monitor local radio and television stations for announcements. We will also do our best to notify parents/guardians via email, Class Dojo and other various means of communication. All final school delays, dismissals and cancellations are at the discretion of Cohutta Arrows Kingdom Academy.

## **Academics**

### **Curriculum**

We truly do not believe that educating children is a one size fits all concept. The following are the core curriculums per subject area that may possibly be used, but not limited to. We will teach the content of these curriculums but will also use various approaches, strategies and techniques to meet the needs of every learner.

We use the Abeka curriculum for all core academic subjects: Language Arts, Reading, Math, Social Studies, Health and Science. We also use Answers in Genesis as supplemental science material. We also reserve the right and the freedom to provide supplementary material to meet the needs of all students.

Bible studies will vary from week to week and month to month depending on the grade groups, our learning themes and concepts.

In addition to these curriculums, we believe learning takes place beyond the four walls of a building or classroom. We want them to become servants, be given hands-on experiences and cultivate a love for working with their hands by cooking, sewing, woodworking, planting, farming, building, crafting and other skills that are vitally important for our children to learn and pass on to future generations.

\*\*\*Hybrid homeschool families will also use the above curriculums.

### **Class Sizes**

Our class sizes will be capped at 10 students in all academic subjects. K4 is capped at 8 students, with a 6 student minimum. In the event, we hire an employee that has a student in a class that has 10 students, the school has the right to make an exception for staffing purposes.

### **Grading Scale & Report Cards**

A grade report will be issued every 9-week grading period. Students K4 will receive grades as well as a progress report accessing their growth. Kindergarten & 1st grade will be assessed on a gradual learning progression scale: (NYD)-Not yet demonstrating, (E) emerging, (DV) developing & (DM) demonstrating. The 2nd-12th grading scale is as follows: A (90-100), B (89-80), C (79-70), Below 70 is considered as failing.

### **Grading Periods**

Each school year is separated into 4 grading periods, approximately every 9 weeks. The first and second grading period form "Semester One" and the third and fourth grading period form "Semester Two". Exact dates are published every year on the approved calendar.

### **Daily Assignments, Late Work & Homework**

A majority, if not all of your child's assignments should be completed at school. If a child misses a day, they are still expected to make the work up. A child may have homework if they are absent, a teacher may assign a special project, or a teacher may give recommendations to improve a skill that would require some practice at home. At Cohutta Arrows Kingdom Academy, we want to ensure academic rigor; however, our most important concern is that your child feels safe, loved and learns the righteous ways of the Kingdom. We hope to equip them to do so in every academic area through their daily assignments. When they go home, we want their focus to be on family and for parents to enjoy the short time they can just be children.

### **Assessment/Testing Policy**

We do not believe in constant assessment of our students. We do believe that the evaluation of every child's learning should take place on a daily basis and we will update every parent/guardian on the progress of their child(ren) through progress reports. Graded work will be sent home weekly. The Georgia Department of Education requires us to administer a nationally recognized norm referenced test for every student enrolled in Cohutta Arrows Kingdom Academy every third year starting in grade three. Cohutta Arrows has chosen to administer the MAP test, Measurement of Academic Progress, a nationally normed referenced test, given every fall and spring for every student, except K4. This not only gives you, the parent, a good indication of your child's growth, but it

also gives us data to evaluate your student's academic strength and weaknesses specific to each subject area.

### **Exceptional Education Services**

#### **Grade Advancement:**

In the event that interest is expressed in a student potentially advancing an academic grade, the steps are followed:

Step One: A written request from the student's family documenting their interest is submitted to administration.

Step Two: A review of the student's past report cards, standardized testing, attendance, self-motivation and behavior records is completed by the Board of Cohutta Arrows.

Step Three: Previous teachers of the student are asked for evidence to support their opinion of the student's potential grade advanced placement.

Step Four: All factors are weighed and are discussed by Administration and the Board before a finalized decision is documented and shared with the family.

\*Additional placement testing may also be used in making the determination.

#### **Academic Learning Plans:**

While we acknowledge and recognize IEPs & 504 learning plans, we do not write federal IEPs or 504 documents. Cohutta Arrows Kingdom Academy Board of Education will be transparent with every family if we cannot meet the exceptional needs of a student/child. The overall goal of the learning plan is to recognize and equip students to become independent and self-sufficient learners. The accommodations will be appropriate for the success of the student. If the student continues to show need for additional accommodations or does not meet the goal established by learning plans, additional accommodations may be needed.

#### **Awards**

Academic Excellence Awards & Character Development Awards will be issued at our annual awards ceremony at the end of every academic school year.

#### **Graduation Requirements**

Starting in 9th grade, every student will receive a visit from a graduation advisor annually through high school to discuss their high school credits and future plans of graduating, possible dual enrollment, and college/trade school. When entering 9th grade, each student will receive a list of graduation requirements and credits.

Requirements for graduation and diploma begin in the 9th grade. The three diploma programs at Cohutta Arrows Kingdom Academy are:

1. College Prep with Distinction: Minimum of 23 credits, including foreign language and at least one DE course
2. College Prep: Minimum of 23 credits, including foreign language
3. General Studies: Minimum of 23 credits

The graduation policies of Cohutta Arrows Kingdom Academy meet or exceed the requirements of the state of Georgia in order to satisfy entrance requirements for state and private universities. Students must earn a minimum of 23 credit hours in grades 9th through 12th, in addition a Bible credit should be earned each year that the student is in attendance.

### **Dual Enrollment**

Students in grades 11 and 12 may take college classes while attending Cohutta Arrows.

### **Promotion Requirements**

In order for a student K5-8th to be promoted, a student must complete 85% of the Abeka curriculum and maintain a 70 or above average. In the event a student maintains a 70 or above average but does not meet the 85% completion requirement, the student will be required to finish the remainder of the curriculum during the summer in order to be placed in the next grade. In the event a student does not complete 85% of the Abeka curriculum and maintain a 70 or above average in 2 or more subjects, a data-meeting will be held with the parents, instructors and administrators to discuss the possible retention and/or placement of the student.

If any student is not on target at the end of the first grading period, a data meeting will be arranged to discuss the needs and assistance of the student. The student will be progress-monitored and documentation will be collected to assess needs. These forms will be saved in a data binder.

### **Attendance Policy**

Even though Cohutta Arrows Kingdom Academy is not required by law to report a child's attendance to the State Department of Education, the state does require the Academy to keep record of attendance. It is the authority of the State Department of Education, as well as our local superintendent (Ga St Code section 20-2-690), to ask for our attendance records at any time and they also have the authority to report excessive absences to truancy. A child is expected to not miss more than 10 school days per fiscal year. Parents and instructors must work together to ensure each child receives the absolute best education. In order to accomplish this, students must attend school with minimal absences. Your child's academic and spiritual success is very important to us. Please send excuse notes for us to file and record.

For every 10 school days missed, an attendance notification letter will be sent home. If a student misses 15 days or more per grading period, the student's attendance situation will go before the Board of Cohutta Arrows for an admissions review. More than 15 days of absences in a grading period will result in loss of credit for the class because of the minimum attendance requirements for each class.

If your child is a full-time Cohutta Arrows student, they are expected to be here every day, Monday through Friday. If your child is in our co-op hybrid program, they will report on their contracted days.

### **Checkouts**

We understand children will have doctors and dentist appointments. If you check your child out, please bring an excuse note for us to file and record for the child's missing time. We do encourage you to use flex-Fridays for appointments. A child will be considered present for the school day if they attend the minimum requirement of 4.5 hours, or 1:00 p.m.

### **Early Dismissals and At-Home Learning Days**

We will have a couple early dismissal days during the school year. These days are considered full days. Children will always be dismissed at 1:00 p.m. on early dismissal days. In situations where the school is closed for an extended period of time, Cohutta Arrows has the right to establish an at-home learning day.

In the event of expected bad weather, a high percentage of sickness or other unexpected issues that result in the school needing to close, we may declare at-home learning day(s). Your child's assignments will be sent home if this were to occur and parents/guardians will be notified if this decision is made by the Administrators.

### **Juniors & Senior College Visits**

Juniors and seniors are permitted to take days out of school for the purpose of visiting college campuses. They need to provide proof of visit in order for these days to count as a NA (non-absent) for the day. All work missed is expected to be made up.

## **Student Life**

### **Activities, Opportunities, Field Trips & School Sponsored Events**

One of the ways we believe children learn best is experiences. We hope to give students real life experiences through field trips and hands-on activities. Field trips, activities and school sponsored events will always be announced with ample notice. All school expectations and code of conduct are required at the activities, field trips and any school sponsored events.

### **FCA, AIM and other clubs**

Cohutta Arrows has a partnership with FCA, Fellowship of Christian Athletes, and gives our students the opportunity to be leaders within the school and community.

**AIM** is our student council committee that allows selective students the opportunity to lead their peers in a positive way.

**Running Club** is completely voluntary and is led by Mr. Grubbs. All races and practices are at the discretion of the club sponsor.

**Worship Team** practice is held every Thursday morning. Only students in grades 7th through 12th are permitted.

### **Backpacks**

Backpacks are allowed at Cohutta Arrows Kingdom Academy. The students will bring home reading books and a green folder that should be checked daily for communication purposes.

### **Textbooks and/or Reading Books**

All textbooks and reading books are property of Cohutta Arrows Kingdom Academy. All school property that is borrowed and/or used is expected to be returned. Any items not returned, or damaged items, are the financial responsibility of the parent/guardian.



## Articles of Faith & Code of Conduct Acceptance

### STEP 4: ENROLLMENT

Cohutta Arrows Kingdom Academy's statement of faith does not exhaust the extent of our faith. The Holy Bible itself is the sole and final source of all that we believe. We believe and fully affirm, in its entirety, every statement declared in our articles of faith and every single word of the Holy Bible. By signing below, you are agreeing and accepting our statement and have full understanding your child will be taught with these Truths.

All students are expected to abide by the Codes of Conduct and policies as outlined in this handbook. Every teacher will use a system of classroom management to encourage the school codes. Students who do not follow the codes of conduct and policies will be subject to disciplinary action. In addition to the Codes of Conduct and policies previously stated, the following expectations also apply:

1. Students are expected to treat worship, prayer and class discussion with proper reverence.
2. Students are expected to obey and respect their parents, faculty & staff of Cohutta Arrows Kingdom Academy and any visiting, supportive adults.
3. Students will demonstrate honesty in all dealings with one another and staff because of fidelity to the truth that is commanded by God and in His word.
4. Students are expected to work diligently on their school work and strive to do their best at all times, as we are to do it heartily, as the Lord commands.
5. Students will refrain from language and actions that are vulgar, inappropriate and demeaning to either God or mankind. Teasing, criticizing, put-downs, insults and name-calling are not permitted.
6. Students are expected to conduct themselves in a manner that is consistent with Biblical principles of purity and holiness, students shall refrain from all forms of inappropriate sexual behavior, including fornication, viewing of pornography, immodest dress, and homosexuality.
7. Students nor staff should ever be in the possession of drugs, alcohol, tobacco or any other illegal substances and is strictly forbidden on the Cohutta Arrows Kingdom Academy and Salem Baptist Church campus. No student shall be permitted to have any type of weapon, including pocket knives on campuses.
8. Students are expected to treat all school and church materials and facilities with respect and care. Students are expected to keep the school and church campus neat and clean.  
Parents/Guardians agree to reimburse the school/church for any damages incurred by student.
9. Since spiritual disciplines are essential to a Christian walk, growth and discipleship, all students will strive to maintain a faithful daily walk with Christ and be active in a local church.
10. Since we are asked by God to serve as ambassadors for Christ and representatives of this Academy, it is expected students will give all effort to conduct themselves accordingly at all times.
