

HOUSEHOLD HAZARDOUS WASTE (HHW)

CLEANSWEEP WILL ACCEPT:

Household hazardous waste will be accepted at the below locations and only at the designated time. Items will be taken for free from residential properties, with the exception of fees charged for bulbs and batteries. Acceptable items include materials such as oil based paints, aerosol spray paints and lubricants, solvents, pesticides, fertilizers, household and hazardous cleaners, corrosives, flammables, mercury, lead tackle and shot, old gas, antifreeze, and other chemicals you wouldn't consider dumping. Mercury containing thermostats, switches and thermometers, and lead based paint will also be accepted. Unwanted Rx will be taken for free. Douglas County residents may attend any of the local HHW collections.



Waste Management, the Douglas County Recycling firm contracted to collect recycling, currently accepts residential plastic food/water containers numbered 1, 2, & 5. In the future, the availability of certain numbered plastic containers may be eliminated from the recycling stream due to limited or no markets to recycle some plastics. Should a specific numbered plastic be identified as no longer acceptable, citizens will be informed of the changes via social media, recycling collection sites, and future recycling newsletters.

*Businesses are not allowed to use the recycling containers as DNR funding does not allow it.

Remember these three basic rules the next time you recycle!



Recycle clean bottles, cans, paper and cardboard.



Keep food and liquid out of your recycling.





No loose plastic bags and no bagged recyclables.
