CONFIDENTIAL, PROFESSIONAL CASEWORK SERVICES

Youth Assistance provides confidential, short-term, family-centered counseling and referral services for young people, 17 years of age or younger and their families, who live within the boundaries of West Bloomfield School District in Keego Harbor, Orchard Lake Village, Sylvan Lake and West Bloomfield Township.

There is a one-time \$25.00 processing fee for all casework services.

Referrals are accepted from schools, police, family members, neighbors and parents themselves with concerns about their child. In addition, the Family Division's Intake Unit diverts cases when, in their judgment, Youth Assistance services are most appropriate; there could be additional costs for court diversion agreements. Typical reasons for referral include retail fraud, school and home problems, truancy, behavior changes, assault, alcohol or other drug abuse and violations of local ordinances.

Caseworker's Report

WBYA Caseworker Stacy Pasini, MPA Oakland County Youth Assistance Caseworker II

The Oakland County Circuit Court - Family Division places professional caseworkers in each Youth Assistance office. West Bloomfield Youth Assistance has one caseworker assigned to the WBYA office. The caseworker provides direct service to all referral families and oversees all volunteer programs.

Caseworkers offer family focused, short-term, voluntary counseling using the following methods: family assessment, short-term counseling, behavior contracting, accountability/police diversion (to avoid official court involvement),

U Turn Jail tour, monitoring behavior, and/or referrals for outside therapy. WBYA receives client referrals from parents, police, community agencies and the West Bloomfield School District.

Most recently, Re-Entry services have begun at the local offices. These services are available to children and families who may have experienced an out of home placement, and need assistance with returning back to their community. All of these services benefit our local youth and work towards fulfilling the Youth Assistance mission of strengthening youth and families through community involvement!!

I look forward to the continued partnerships with the West Bloomfield School District, our local police departments in Keego Harbor, Orchard Lake and West Bloomfield, and our many community partners that work tirelessly to help the children and families in our community.

In the fall of 2017, we look forward to announcing an exciting new community event that is guaranteed to bring families together. Check out our Facebook page for more details in the next few months.






Residing City



Reason for Referral



Summer Camp Committee Report

Summer Camp Scholarship Committee: Curt Lawson, Kelly Hyer, Stacy Pasini



In 2017, the Camp Scholarship Committee received requests from 11 applicants. Nine were found to meet our criteria for scholarships. We are pleased to report that \$2000 was given toward Scholarship requests. This number is down from previous years, but we have found it necessary to limit our funds this year to balance our budget. There were five applicants were from Keego Harbor area and 5 were in the West Bloomfield area. Four applicants were funded through a restricted fund from Keego Harbor CDBG. Each Roosevelt Camp applicant was awarded \$250 of CDBG funding with the family expected to pay the remaining \$175 of this year's cost of \$425. It was voted on to decrease the Summer Camp Scholarship fund given the current trend of decreased applicants. The vote was proven valid as we went from 39 applicants in 2016 to only 11 applicants in 2017. The board will discuss ways to increase visibility of Summer Camp Scholarship availability in the future for 2018.

Youth Assistance Program Structure

Youth Assistance programs are community-based, & developed by volunteers who live and/or work in the communities in which they serve. The Circuit Court provides the professional staff to work with the volunteers & provide direct casework services. Each Youth **Assistance Program is** sponsored by the municipalities and Board of Education contained within that particular school district and the Probate **Court/Circuit Court - Family Division of Oakland County.**

Local Funding For Youth Assistance

WBYA's continued annual local funding is a result of sponsorship resolutions passed by each municipality in 1969.

The local sponsors (school district & municipalities) are responsible for the operational & programmatic expenses of running the local Program.

West Bloomfield Youth Assistance operates under the sponsorship of the West Bloomfield School District, the City of Keego Harbor, the City of Orchard Lake, West Bloomfield Township, and the Probate Court/Circuit Court-Family Division. Additional funding is obtained through grants, donations, & local fund-raising efforts.

Assistance Coordinating
Council, Inc. provides advice,
consultation, and support to the
Central Office and to the local
Youth Assistance Boards. The
Council provides training for
local officers and coordinates
county-wide events. It
seeks and distributes grant
monies to the local Boards,
and produces the Youth
Assistance newsletter.

Family Education Committee Report

The Family Education Committee presented a robust agenda filled with new speakers, new partnerships and a brand new parenting program called Parenting On The Go. The online program, which features short videos presented by local experts, is designed to support busy parents and guardians of children who reside in Greater West Bloomfield and direct families to local resources that they might otherwise be unfamiliar with. The videos are produced in collaboration with Civic Center TV. The first set of videos shed light on over scheduled families, opioid and heroin abuse, and suicide prevention. The presenters included Psychologist Melanie Schwartz, Drug Enforcement Agent Richard Isaacson, Sergeant Todd Metcalf of West Bloomfield Police Department, Jewish Family Service Senior Director of Family Life and Wellness, Erica Saum and Oakland County Health Division Youth Suicide Prevention Task Force Chair, Hannah Cassise. To further strengthen families, West Bloomfield Library is also a partner of the Parenting On The Go campaign and will lend a hand by stocking parenting books that build on the presenter's expertise.




Award Recipient
