On May 19, 2025 the Regular Meeting of the Attica Town Board was held in the BoardRoom of the Municipal Building, 9 Water Street, Attica, New York, with the following members present:

The workshop commenced at 6:30 pm. The Board Members reviewed the Abstract, the Supervisor's, and Town Clerks Reports.

At 7:00pm Supervisor Kehl called the meeting to order with the Pledge to the Flag. Supervisor Kehl then requested a moment of silence to honor our military.

PRIVILEGE OF THE FLOOR/PUBLIC CONCERNS:

- Supervisor Kehl welcomed guests to the meeting.
- Art Klein of 3921 Fullington Rd. stated he would like to Thank Larry Diehl Highway Superintendent for taking down the trees on the road.
- Dr. Kiel Illg Superintendent of Attica School District was present regarding an intermunicipal agreement between the Town of Attica and the Attica School District. The district has been contracting with Attica Bus for the last 30 years and the contract will be expiring June 30, 2025. We would like to come up with an agreement with the town to assist with fuel tanks and fueling needs for maintenance vehicles, (2) trucks and (3) vans. We would come up with an agreement and Under the agreement the town shall permit the district to fuel its maintenance vehicles at the fueling station located at the Town of Attica Highway Department and it would be for access to unleaded gasoline and diesel fuel. A log will be kept each time any fuel is being removed and the town will invoice the district monthly and payment will be due from the district within 30 days of receiving the invoice. Prices are subject to change monthly. Supervisor Kehl has been working on this with the Town Attorney.

Dr. Illg stated they have looked at bringing fuel tanks onto the school property; it would cost millions of dollars. The schools insurance carrier is Tompkins Insurance and they have been in discussion with them in regards to the matter.

The fuel tanks now are owned by Residorf, it was suggested that the town look into possibly upgrading the system so you could track it electronically, for example put in a code to get access to the fuel. It will order fuel when it gets low and it will automatically be refueled. Additional fees would be charged for the upgrading.

The next town board meeting will be held on June 16, 2025 at 9 Water St. Attica, NY workshop 6:30pm meeting 7pm.


TODD MCCONNELL SCHOLARSHIP:
