PRIVILEGE OF THE FLOOR/PUBLIC CONCERNS:

Shirl Clark Dog Control Officer gave an update on dog licensing within the town. The last clerk purchased a tablet or laptop for the dog licenses and she would like to know if the town has it. Supervisor Kehl will check on it.

The Village Mayor Nathan Montiford was present and asked about the rent check? Supervisor Kehl handed it to him.

A lengthy discussion was had.

Supervisor Kehl stated that I spoke to you (referring to the Mayor) back in July and you were going to get back to me, and I didn't hear from you. In August we wrote a check for \$1,200.00 because it excluded the clerk's office.

Supervisor Kehl stated that we are not going to sign a contract with the Village for rental space when the clerk's office is excluded. We are losing space and we are not getting a discount on the rent.

Barb Higgins: I have been working on the Comprehensive Plan and just waiting on various maps from the County. Once she gets all the information together she will submit it to the town board for review and then it will need to go to the County and the Town Attorney. The Stevens Solar Farm did replant new arborvitae.

Bill Gerhardt Sr.: I live on Gulf Rd. I reached out to Claudia Tenny's Office (Federal Office) and George Burello's Office (NY State Senator).

I was told I need to address this issue locally with the town board.

This is an emergency issue, and putting people's lives at risk, this has to be resolved.

Supervisor Kehl stated that he has had conversations with the railroad Tenny's Office and Burello's office about this and have had the same results. The train has 2 engines. If they have trouble with 1 engine they have to wait for the train to come from Buffalo to pull them up over the hill. The train is 2 miles long.

The Village has sent emails and complained about it as well. They can only ride for a certain time and then they have to stop.

Supervisor Kehl I feel your frustration. I will look into this.

VILLAGE LIAISON:

Justin Lane handed out a study summary of the Village of Attica's High Street/Rt. 98 Speed Transition

Study Summary:

This was a two-week traffic speed study that analyzed the Rt. 98/High St. transition area within the Village of Attica using two Black Cat radar counters. The objective was to assess speed behavior changes between the 30 mph and 55 mph zones within the limits.

Key Findings:

- Counter 1 (30 mph zone) recorded northbound speeds exceeding 80 mph
- Counter 2 (55 mph zone) recorded a top speed of 92.6 mph southbound
- Average speeds increased nearly 50% moving from the 30 mph to 55 mph zone, even though both counters are within village limits.
- Pickup trucks averaged slightly higher speeds than other classes.

Observation:

High speed entries into the Village pose a safety hazard for residents entering from driveways or side streets. Consideration should be given to a posted speed transition zone reduction or extending the 30 mph buffer.

More information to come.
