
TOWN OF ATTICA MEETING MINUTES APRIL 19,2024

A REGULAR MEETING OF THE ATTICA TOWN BOARD WAS HELD AT THE MUNICIPAL BUILDING 9 WATER STREET, ATTICA NEW YORK. THE MEETING WAS CALLED TO ORDER BY TOWN SUPERVISOR KEHL, AT 7 PM.

CRITICAL ACCESS- FEDERAL GOVERNMENT REQUIRE MENTAL HEALTH BEDS TO BE CUT FROM 12 TO 10- FEDERAL GOVERNMENT HAS BEEN DELAYED IN PROCESSING. TO ACCOMMODATE THE LOSS OF BED SPACE A RENOVATION IS UNDERWAY TO ADD BEDS IN ER FOR MENTAL HEALTH PATIENTS.

50-60% OF BEDS IN MENTAL HEALTH UNIT ARE OUT OF COUNTY RESIDENTS, MAKING IT DIFFICULT TO REDUCE THE NUMBERS.

COUNTY EMS SERVICE STARTED IN DECEMBER, VERY EXPENSIVE, STILL WORKING OUT THE KINKS.

VOLUNTEER FIRE DEPARTMENTS LACKING HELP. IF MORE VOLUNTEERS DON'T COME FORWARD, COUNTY WILL HAVE TO GO TO A PAID SERVICE.

BIDES OPENED LAST WEEK- \$3.6 MIL FOR FIRE TRAINING CENTER UPDATE.
