WATER DISTRICT RESOLUTION 2025- 54:

**RESOLUTION IN SUPPORT OF THE VILLAGE APPLICATION FOR A 2025
NEW YORK STATE WATER INFRASTRUCTURE IMPROVEMENT ACT (WIIA) GRANT**

WHEREAS, the Town of Attica intends to purchase drinking water from the village of Attica Public Water Supply (PSW ID#NY6000607); and

WHEREAS, the Village of Attica owns and operates a Water Treatment Plant and requires a redundant transmission main to provide reliable potable water service to its service area and connections in the town of Attica; and

WHEREAS, NYS Environmental Facilities Corporation is offering grants for clean and drinking water projects during the 2025-2026 state fiscal year to selected municipalities with infrastructure projects that protect public health and/or improve water quality; and

WHEREAS, the Village of Attica is seeking funding through the NYS Water Infrastructure Improvement (WIIA) Grant; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately.

RESOLUTION

WHEREAS, the Town has received a "MAP, PLAN and REPORT" ("MPR") prepared by Labella Associates as described by Town Law Section 190-c for creation of Water District No. 1 and a Petition of Property Owners within the proposed Water District No. 1 based on the "MPR"; and

WHEREAS, the Town has conducted a public hearing on July 21, 2025 as required by Town Law Section 190-c concerning this District; and

WHEREAS, the Attica Town Clerk has certified that more than one-half ($\frac{1}{2}$) of the Petitioners being owners of taxable real property situated in said District have signed said Petition and that the assessed valuation of the signators' properties is greater than fifty percent (50%) of the total value of the assessed value of all properties included in the District.

NOW, THEREFORE, BE IT RESOLVED, that the Town of Attica hereby establishes Water District No. 1; and it is further

RESOLVED, that the Supervisor and Town Clerk of this Board, with the approval of the Town Attorney, are authorized to sign any and all applications and agreements, including, but not limited to, an Intermunicipal Agreement with the Village of Attica, New York concerning ownership of the transmission line, cost of project and application to grants available for the project described in the "MPR".
