# Parking Lot Rules and Regulations:

2020-2021

(Student is to read and initial each line)

- \_\_\_ Hang tag must be displayed at ALL TIMES.
- \_\_\_ Parking in NON-RESERVED spaces in student lot ONLY.
- \_\_\_ Student drivers must follow all Florida Motor Vehicle Rules and Regulations. Speed limit is 5 mph. No loud music, tire skidding/sliding or careless driving.
- \_\_\_ The School is not responsible for damages or theft to automobiles, trucks, bicycles, or motorcycles or the content of these vehicles.
- \_\_\_ You must enter the building once parked. No loitering in the parking lot without administration permission.
- \_\_\_ You cannot access your car without written administration permission during the school day. This includes between classes and during lunch. VIOLATIONS WILL RECEIVE DISCIPLINARY ACTIONS.
- \_\_\_ The student parking gates will be locked daily. Any student arriving late to school must report to the Student Affairs Office and sign-in. Students leaving for dual enrollment or OJT will be released once the period bell rings. It will be open long enough for cars to exit. Students must leave campus promptly.
- \_\_\_ Student drivers that are habitually TARDY TO SCHOOL (FIVE OR MORE TIMES) CAN LOSE their driving privileges.
- \_\_\_ Any student found LEAVING or ATTEMPTING to LEAVE CAMPUS without permission will face disciplinary actions and/ or loss of driving privileges.
- \_\_\_ Student vehicles may be subject to search if there is probable cause to believe that drugs, alcohol, stolen property, weapons, or any other contraband might be present in the vehicle. If these are found in the vehicle, the student is subject to the same disciplinary actions as if they were found in the student's possession in the school building.
- \_\_\_ Choice Hardship assignment to a school does not guarantee a parking space
- \_\_\_ Sharing of tags or copying tags will result in forfeiture of tags and parking privileges.

**Students violating any parking regulations shall be subject to the following consequences:**

- \_\_\_ First Offense - Written warning to be signed by student driver.
- \_\_\_ Second Offense - Parking fine of \$25.00. Fees added to student debt.
- \_\_\_ Third Offense - Additional \$25.00 fine and suspension of parking privileges on campus for the remaining of the semester. Fees added to student debt.
- \_\_\_ Fourth Offense - Additional \$25.00 fine and suspension of parking privileges on campus for the entire school year and disciplinary action. Fees added to student debt.
