 - As a continuous attending member, with 2 or more years of sobriety and not working with sponsor, could chair meetings without a sponsor
 - 2. Is appropriate for chairs to be working with a sponsor helps guide us and keeps us in solution
 - 3. Yes, there is a benefit to having a sponsor, but does it have to be a requirement? If the chair is willing to stick to the program isn't this okay?
 - 4. Regular attendance, certain period of sobriety (2 years). Not necessary for the requirement of working with a sponsor.
 - 5. Check in with another alcoholic (and a sponsor) is vital
 - 6. All we can share is our own individual experience. There are times in sobriety with no sponsorship. Do not need a sponsor to share experience, strength and hope.
 - 7. 90 days sobriety is key and sponsorship is not.
 - 8. If someone has been in the program and has been attending meetings regularly in the same group, it's not important to have a sponsor. They have a big sober network.
 - Sponsorship has been useful and has been important to maintain protocol. Should remain in our format. Purpose of our meetings is for our newcomers. Someone leading a meeting is counseling newcomers to get a sponsor.

- 10. Perhaps could be a codicil to the format have worked a 12-step program with a sponsor, etc., but might not currently have one, and would like to chair.
- 11. Doing something without a sponsor is dangerous
- 12. Do not see this as an exception

 - i. So many newcomers to BackPorch we are taught to work the steps with a sponsor.
 - ii. Feel much more comfortable with the people chairing this meeting to have a sponsor
 - d. 6 abstaining votes
 - e. Vote carries?
 - f. Discord ensues substantial unity
 - 3. 6 months sober no sponsorship currently
 - 4. Motion modify requirement for removing sponsorship requirement
 - 5. Motion to table until next month's meeting
 - a. Second motion to table until next month
 - b. Third
 - c. 11 approved passed and tabled until next month
