Frank & Amanda Carlock Scholarship Fund This scholarship was created by Martha Green in Memory of Frank and Amanda Carlock. The scholarship will be awarded to a graduate of Jennings County High School who is likely to succeed in their post-secondary studies. First priority will be residents of Paris Crossing and second priority will be to someone who attended Hayden Elementary. If no applicants with these priorities, it will be awarded to any deserving student who resides in Jennings County.

Jacky Koenig Jr. Memorial Scholarship This fund was created in memory of Jacky Koenig Jr. to benefit students pursuing further education that have participated in Track and Field or Cross Country at Jennings County High School.

Jan Ludwig Memorial Scholarship Fund This scholarship was created in memory of Jan Ludwig by her husband to provide scholarships to graduating seniors from the Jennings County High School who are admitted for study at an accredited Indiana college or university in special needs education.

Jennings County ARC Scholarship Fund The purpose of the Fund shall be to provide educational financial support for educational scholarships for students who are accepted into and attend accredited two- or four-year public or private institutions of higher learning and in particular to such students who meet the following qualifications: Student(s) who will be graduating from Jennings County High School and will be pursuing a degree in the field of Special Education. Should there be no eligible candidate(s), the foundation or its designee will exercise the option of not awarding a scholarship for that particular year.

Jennings County High School Alumni Scholarship Fund This fund was created to provide scholarships for qualified students graduating from Jennings County High School who are deserving of financial assistance and who are likely to succeed as college or university students.

**Jennings County High School Class of 2015 Scholarship Fund** This fund was established by the Class of 2015 to provide scholarships to JCHS graduating seniors who will be attending a private or public institution of higher learning.

Jennings County Farm Bureau Scholarship Fund This fund was established to provide a scholarship to a deserving Jennings County High School graduating senior who has a parent or guardian that is a member in Indiana Farm Bureau as selected by the Agency with assistance from a representative of the Foundation.

Jennings County School Nutrition Association Scholarship Fund This fund was established to provide a scholarship to students who have been accepted into an accredited two-or four-year college and whose family member is an employee of Food Service or someone going into Food Services.

Jennings Water/Ed Wessel Memorial Scholarship Fund This scholarship was created in memory of Ed Wessel to provide scholarships for qualified students who are related to Jennings Water Cooperative-residents of Jennings County or a county served by Jennings Water who are graduating from high school or accredited program of adult education conferring high school diploma or GED who are likely to succeed in their studies.
