



# BIRTHDAYS AT THE CARPENTER CENTER



Celebrate your special day with your friends and flip in our amazing Tumbling Pavilion!!! Swing from ropes, jump on the tramps, dive into the ball pit, and enjoy floor time fun.

## What We Provide

- One hour tumbling time with one coach per first 15 tumblers; more coaches required for larger parties
- Safety orientation for all party attendees
- Refrigeration for cake and refreshments
- 30 minutes access to space for cake/gifts

## What You Provide

- Any decorations, paper goods, tableware, cake, and other food/drinks you choose (no confetti or alcohol, please)
- Trash clean up and wiping table at end of party
- Completed RELEASE FORM with parent signatures submitted on party date – anyone who will be jumping/using the gym MUST have release form signed by his/her parent or cannot be on the gym floor.
- Final payment and total head count due at least three (3) days before party date

## Because we want everyone to be SAFE, we require adherence to the following rules:

1. ALL party-goers are required to participate in a safety orientation prior to gym use, which happens at beginning of gym time on day of the party
2. Each party guest must have a parent sign the RELEASE FORM. Only those with parent signature are allowed to be in the gym space
3. All party-goers are to remain within tumbling pavilion until end of party
4. **Dress appropriately for the activities – shorts & t-shirt, or leotard; bare feet (no belts, buckles, zippers, or jewelry, please)**
5. Food or drink is only allowed in the party space, not in the GYM. Gym time will always be prior to eating

## Payments:

- \$100 due at time of reservation. We require reservations be made at least seven (7) days in advance. Remaining balance due three (3) days prior to party date, or deposit is forfeited. **No final payments are accepted on the day of the party.**
- Refunds and/or rescheduled dates can be honored with request submitted in writing to Carpenter Center seven (7) days prior to party date.

## Fees:

\$160 for the first 15 tumbling participants. A participant is anyone who is jumping in the gym space --- this means children, birthday person, and/or siblings. More than 15 tumblers are welcome, with the additional cost of \$50 for extra jumpers up to 10 people. Final head count, adults included, is due with final payment.
