Ingredients: Aqua (Deionised Water), PEG-40 Hydrogenated Castor Oil, COSGARD preservative (*Benzyl alcohol & dehydroacetic acid*) and essential oils (1.98%) of *Citrus aurantium* (Petitgrain), *Vetiveria zizanioides* (Vetiver), *Lavandula angustifolia* (Lavender), *Pogostemon cablin Blanco* (Patchouli), *Chamaemelum nobile* (Roman Chamomile), *Santalum album* (Sandalwood) and *Jasminum grandiflorum absolute* (Jasmine), *Linalool, *Linalyl acetate. *Occurs naturally in essential oils. Allergens listed in bold.

Storage instructions: Store in a cool, dark place, **out of direct sunlight**. **Keep out of reach of children and pets.** Store in original container. Discard after expiry date.

Instructions for use: Shake well, point away from the face, hold at least 15cm from linen and spray a few times onto pillow/bed linen or into the air. **DO NOT SPRAY NEAR EYES/FACE. DO NOT INGEST.** Test a small area of linen to ensure fabric does not stain. Avoid using daily for long periods, to ensure the essential oils keep their beneficial aromatic properties and to reduce adverse effects. If using daily, have a 1 week break for every 6 weeks, to avoid this.

WARNING: NOT TO BE USED BY BABIES, CHILDREN AND PETS. DO NOT USE IF YOU HAVE, OR SUSPECT YOU HAVE AN ALLERGY TO ANY OF THE INGREDIENTS.
