

Invigorating Head Massage Oil with Rosemary, Peppermint & Coconut product information sheet

Ingredients: Cocos nucifera (Coconut oil), Ricinus communis (Castor oil), Tocopheryl acetate (Vitamin E) and essential oils (2%) of Rosmarinus officinalis (Rosemary), Mentha piperita (Peppermint), Citrus paradisi (Grapefruit), Cananga odorata (Ylang Ylang) & Lavandula angustifolia (Lavender), *Eucalyptol, *Linalool, *Linalyl acetate, *Menthone, *alpha-Pinene, *beta-Caryophyllene and *dl-Limonene. *Occurs naturally in essential oils. Allergens listed in bold. CONTAINS COCONUT OIL.

Storage instructions: Store in a cool, dark place, **out of direct sunlight. Keep out of reach of children and pets.** Store in original container. Refrigerate if possible, as this will keep your blend fresher for longer. Discard after expiry date.

Instructions for use: Shake well before use. Warm a small amount of oil in the palms of your hands and massage into the scalp, avoiding the face area and ensuring product doesn't drip into the eyes. Leave on the head for at least 30 minutes or for best results apply at night and leave overnight (using a towel to cover your pillow) and wash off in the morning. Apply usual shampoo onto hair before wetting to help release oils from the hair during washing. Use 2-3 times a week. Avoid using daily for long periods, to ensure the essential oils keep their beneficial aromatic properties and to reduce adverse effects. If using daily, have a 1 week break for every 6 weeks, to avoid this.
